Ford read the May financial update for the district. The total of all receipts and beginning balance \$10,193,605.71 and disbursements \$2,840,627.43, with the balance at the close of the month totalling \$9,053,753.35. General Fund Balance consisted of Fund 1: \$5,452,129.45; Special Projects \$-59,254.23; District Activity Fund \$1,588.54; Capital Outlay Fund \$270,783.00; FŠPK Building Fund \$167,950.43;

struction Fund \$3,034,204.89; Debt Service Fund -253.712.51; Food Service Fund \$435,986.08; and Fiduciary Fund \$4,077.70.

In other school board news, the discussion of renewal for Property, General Liability, and Fleet Insurance was brought to attention. Ford discussed the savings the school was going to have due to the school buses being parked and not being driven for so long due to the pandemic. He also stated that there would be some reimbursement for this due to the lesser amount of mileage on the buses and drive time.

Ford went on to say that

the current insurance for those items listed above expires July 30 of this year, with \$115,847 as the first installment, and then the remaining half is paid January 2021. He recommended that the members renew their policy with Liberty Mutual from McKinney & Blair as well as Griders Insurance Agency. The motion was made and approved.

The school calendar was up for discussion as well. The school board originally approved school to start back on Tuesday, August 18. Ford spoke of how much uncertainty was still going on due to the pandemic.

One of the options discussed when starting school back is the Variable Student Instructional year. This is where school districts are still bound to the 1062 hours if they start closest to the Monday of August 26, but not bound to the 170 instructional days.

recommended the board members to amend the 2020-2021 school calendar to implement the Variable Student Instructional Year. The amended calendar that was voted on and passed will include 164 instructional days with the first day starting August 26. Ford said this will give the school system a little more flexibility and a little later start.

However, a reentry plan has not been put into plan or on paper. Superintendent Ford said they are waiting on the Kentucky Department of Health regarding school and what next steps to take.

In close at the school board meeting, Ford said the Chromebooks have been ordered for Russell County Students to begin using starting for the 2020-2021 school year.

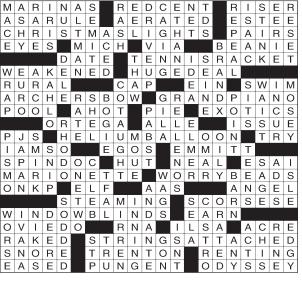
