Adopted: Second Amendment Sanctuary Resolution

Green County Fiscal Court, in its regular called meeting Thursday evening, approved a resolution by a 5-0 roll call vote, making Green County a Second Amendment Sanctuary County.

Magistrate Tim Darnell said, "I firmly believe that the U.S. Constitution Second Amendment ensures law-abiding citizens the right to keep and bear arms. I join with my fellow magistrates in approving a resolution declaring Green County as a Second Amendment Sanctuary County." County govern-

ments from around Kentucky have joined in the effort to protect the rights of law-abiding citizens to keep and bear arms. The resolution.

passed by the magistrates, reads in part as follows: Therefore, Be It Resolved, the People of Green County, through their duty elected Fiscal Court hereby designate Green County a Second Amendment Sanctuary in order to preserve for the People of, on, and in Green County, their rights guaranteed by the Constitution of the United States of America, furthermore that the Green County Fiscal Court hereby expresses its intent to uphold the Second Amendment rights of the citizens of Green County, Kentucky, and, furthermore that the Green County Fiscal Court hereby declares its intent to oppose any infringement on the right of law-abiding citizens to keep and bear arms. We, the People of Green County, Kentucky, through this resolution hereby declare our rights, our freedom, and our liberty as guaranteed by the Constitution of the United States of America.

"I am very pleased that the court passed the resolution regarding the Second Amendment. Because of what's happened recently in the state of Virginia, local gun owners are very concerned with their rights being infringed upon regarding their right to bear arms. The Fiscal Court, including myself, want it to be very plain as to our support for the Second Amendment. The court is glad to take a stance

and offer our support," said Judge-Executive John Frank.

By roll call votes of 4-0, with one abstention, Fiscal Court approved the second reading and adoption of an ordinance objecting to the striking of territory from the City of Greensburg's boundaries as proposed in city ordinance 2019-0812, pursuant to KRS 81A.440.
