He said he would work from the Executive Mansion near the Capitol and give his daily briefings via video from there.

The news release noted that the family is in quarantine, not isolation, which "is used to separate people infected with .. the virus that causes Covid-19 from people who are not infected."

Daily numbers and some suggestions: The 852 new cases Sunday were far above any other Sunday, except the 979 reported in July 19, near the peak of the last major surge in cases. The average for the 11 Sundays between that one and this one is 444. Case numbers on Sundays are usually the lowest of a week because of limited testing and reporting on weekends.

The big number also gave the state's Mondayto-Sunday reporting week the highest number of cases yet. The total of 7,792 includes 1,472 from a reporting backlog in Fayette County, but even if that number is subtracted, the 6,320 remainder is still the highest for a week. The state issues adjusted, final about 1.5 percent of cases like fall festivals, church are removed from the initial totals after duplicate events. Acknowledge test results are removed. ONSTITUTIONAL AMENDMENT 1

ection 1. Are you in favor of creating a new ection of the Constitution of Kentucky relating crime victims, as proposed in Section 2 elow?

ECTION 2. IT IS PROPOSED THAT A NEW ECTION BE ADDED TO THE ONSTITUTION OF KENTUCKY TO READ S FOLLOWS:

o secure for victims of criminal acts or public ffenses justice and due process and to nsure crime victims a meaningful role roughout the criminal and juvenile justice stems, a victim, as defined by law which kes effect upon the enactment of this section nd which may be expanded by the General ssembly, shall have the following rights, hich shall be respected and protected by law a manner no less vigorous than the rotections afforded to the accused in the riminal and juvenile justice systems: victims hall have the reasonable right, upon request, timely notice of all proceedings and to be eard in any proceeding involving a release, lea, sentencing, or in the consideration of any ardon, commutation of sentence, granting of reprieve, or other matter involving the right of victim other than grand jury proceedings; the ght to be present at the trial and all other roceedings, other than grand jury ccused; the right to proceedings free from nreasonable delay; the right to consult with e attorney for the Commonwealth or the torney's designee; the right to reasonable rotection from the accused and those acting n behalf of the accused throughout the riminal and juvenile justice process; the right timely notice, upon request, of release or scape of the accused: the right to have the afety of the victim and the victim's family onsidered in setting bail, determining whether release the defendant, and setting onditions of release after arrest and priction; the right to full restitution to be paid y the convicted or adjudicated party in a anner to be determined by the court, except at in the case of a juvenile offender the court shall determine the amount and manner of paying the restitution taking into consideration the best interests of the juvenile offender and the victim: the right to fairness and due consideration of the crime victim's safety, dignity, and privacy; and the right to be informed of these enumerated rights, and shall have standing to assert these rights. The victim, the victim's attorney or other lawful representative, or the attorney for the Commonwealth upon request of the victim may seek enforcement of the rights enumerated in this section and any other right afforded to the victim by law in any trial or appellate court with jurisdiction over the case. The court shall act promptly on such a request and afford a remedy for the violation of any right. Nothing in this section shall afford the victim party status, or be construed as altering the presumption of innocence in the criminal justice system. The accused shall not have standing to assert the rights of a victim. Nothing in this section shall be construed to alter the powers, duties, and responsibilities of the prosecuting attorney. Nothing in this section or any law enacted under this section creates a cause of action for compensation, attorney's fees, or damages against the Commonwealth, a county, city, municipal corporation, or other political subdivision of the Commonwealth, an officer, employee, or agent of the Commonwealth, a county, city, municipal corporation, or any political subdivision of the Commonwealth, or an officer or employee of the court. Nothing in this section or any law enacted under this section shall be construed as creating: 1) A basis for vacating a conviction; or (2) A ground for any relief requested by the defendant. YES NO

CONSTITUTIONAL AMENDMENT 2

Section 1. Are you in favor of changing the term of Commonwealth's Attorneys from sixyear terms to eight-year terms beginning in 2030, changing the terms of judges of the district court from four-year terms to eight-year terms beginning in 2022, and requiring district judges to have been licensed attorneys for at least eight years beginning in 2022, by amending the Constitution of Kentucky to read as stated below?

Section 2. It is proposed that Section 97 of the Constitution of Kentucky be amended to read as follows:

In the year two thousand, and every six years thereafter, there shall be an election in each county for a Circuit Court Clerk, and, until the year two thousand thirty, for a

Commonwealth's Attorney, in each circuit court district, unless that office be abolished, who shall hold their respective offices for six years from the first Monday in January after their election, and until the election and qualification of their successors. Beginning in the year two thousand thirty, and every eight years thereafter, there shall be an election for a Commonwealth's Attorney in each circuit court district, unless that office be abolished, who shall hold his or her office for eight years

from the first Monday in January after his or her election, and until the election and qualification of his or her successor

Section 3. It is proposed that Section 119 of the Constitution of Kentucky be amended to read as follows:

Justices of the Supreme Court and judges of the Court of Appeals and circuit court shall severally hold their offices for terms of eight years, and until the year two thousand twentytwo, judges of the district court for terms of four years. Beginning in the year two thousand twenty-two, judges of the district court shall hold their offices for terms of eight years. All terms commence on the first Monday in January next succeeding the regular election for the office. No justice or judge may be deprived of his term of office by redistricting, or by a reduction in the number of justices or judges.

Section 4. It is proposed that Section 122 of the Constitution of Kentucky be amended to read as follows:

To be eligible to serve as a justice of the Supreme Court or a judge of the Court of Appeals, Circuit Court or District Court a person must be a citizen of the United States licensed to practice law in the courts of this Commonwealth, and have been a resident of this Commonwealth and of the district from which he or she is elected for two years next preceding his or her taking office. In addition. to be eligible to serve as a justice of the Supreme Court or judge of the Court of Appeals or Circuit Court a person must have been a licensed attorney for at least eight years. Beginning in the year two thousand twenty two, no district judge shall serve who has not been a licensed attorney for at least eight years.

Section 5. The eight-year licensure requirement for district judges set forth in the amendment to Section 122 of the Constitution shall not apply to any person serving as a district judge on the effective date of this amendment.
