Prescribed fire, also known as a controlled burn, refers to the controlled application of fire by a team of fire experts under specified weather conditions that helps restore health to fire-adaptive environments.

"Prescribed fire is one of the most effective forest management tools the MFC Over the last decade, tions to prevent the fire from has," Bozeman said. "Additionally, prescribed fire, when properly applied to a landscape, can significantly reduce the chance of catastrophic wildfires."

Prescribed fire safely reduces excessive amounts of brush, shrubs and trees from the understory. By having a prescribed fire plan for their property, landowners continuously reduce the amount of fuel available should a wild-

fire start. Less fuel means less chance of a wildfire reaching a catastrophic level.

"Wildfire prevention requires a multifaceted approach, and it takes everyone working together," said Bozeman. "The MFC uses prescribed fire as a way to help reduce the chance of large scale wildfires, but we also ask the public to use extreme caution when burning outside."
