

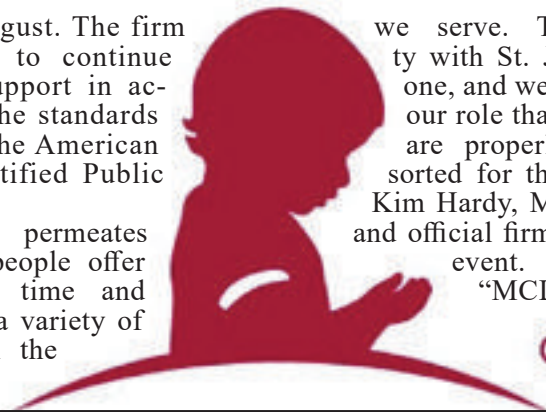
Matthews, Cutrer and Lindsay signs on as Jackson's St. Jude Dream Home® Giveaway CPAs
