

City working to remedy water billing late fee error

According to the City of Clinton, while under the Public Service Commission Order for coronavirus, no late fees and disconnections may be charged to utility customers.

Due to a coding error by the City's water billing contractor, some residents improperly received a \$15 late fee on their April 2020 water bill. Public Works officials are aware of the billing error and are correcting the bills of affected customers.

The City's billing contractor has assured the City that the error has been remedied for the May 2020 billing cycle.

Residents may contact 601-924-2239 with any concerns regarding this matter.

The Public Service Commission Order states that customers should continue to pay their utility bills for utility services utilized during this time. PSC Commissioners encourage customers to continue paying their bills to avoid extreme balances at the end of the sixty days and to work with service providers should other matters cause hardships.

Once the PSC order is lifted, City officials will return to the regular billing and disconnection cycle.
