Sumner declares emergency

Thursday, March 19, the Sumner Town Board declared an Emergency by Resolution in response to the COVOID-19 pandemic and the subsequent orders of the President and Governor. Declaring an emergency allows the town to expedite the use of resources and take any measures needed to protect the health, security, safety, and well-being of its residents, public, and the town employees. John Dohner, Town Board Chairman stated "We are trying to assure the continuity and reliability of town operations." For this reason, Dohner also issued a proclamation limiting access to the town hall and office. Appointments will be needed to conduct business at the town office. This measure has been implemented as one more means to provide protection for the public health, safety and welfare of the officers and the public, as well as ease the burden of the clerk as she prepares the election under extraordinary conditions, including a spike in absentee voting and shortages and/or absence of election materials and sanitation supplies.

The proclamation also addresses the upcoming election. The April 7 election will be conducted providing the same opportunities to cast your vote. In-person registration and voting will be provided during established election hours (7 a.m. to 8 p.m.). Although governmental facilities are exempt from the maximum ten-person gathering order, with six to seven election inspectors onsite, electors will be limited to three at any one time within the town hall for the purpose of reg-

istering and voting. The Sumner Town Hall is a confined space and this will require safe distances to better protect electors and election workers. All voters should dress appropriately for the weather conditions, in case of a line outside of the town hall.

Dohner added, measures are meant to protect our public. As conditions change, the town board and the clerk are prepared to address them as needed." The Emergency by Resolution, proclamation and further notices can be found on the town's website at www.townofsumner.com. In addition, the guidelines established for voting on April 7 will be posted on the Town of Sumner website. Please note we are encouraging absentee voting via www.my.wi.gov in order to reduce risk of exposure to the COVID-19 virus.

Lukas further explained, 'Evone and Daniel Walsh were busy, as a lot of people are on Saturdays, working around their house, when Evone heard the smoke detector go off and acted quickly.'

Though Lukas lives in the City of Milton and serves as its battalion chief, his full-time job is the battalion chief for the Janesville Fire Department. Regardless, the Walsh's were glad that Lukas and a combination of fire departments came to the couple's rescue that Saturday morning.

Lukas said in a post-incident interview, that besides the fire departments of Janesville, and Edgerton, there were quite a few others that were also called upon.

He indicated, "We wanted to make sure we had enough water to fight the blaze, so we asked for water tankers from Orfordville, Clinton, Whitewater, Footville, and Town of Turtle just to make sure."

One of the firefighters dispatched from Edgerton was division commander Brandon

Whitmore, who was on scene to confront the conflagration and served as water supply officer.

"Fortunately," Lukas iterated, "We got the fire out

"Unfortunately," he added, "there was significant heat and smoke damage to the inside of the home, though we managed to stop the fire itself from entering the home.'

The battalion chief said the blaze was entirely contained to the garage itself, with only some external fire damage to the exterior of the home.

EFPD's Pickering said, "Fire crews from Milton, Edgerton and Janesville found the bulk of the fire was coming from the garage and did an outstanding job stopping the fire from consuming the entire house."

Upon approaching the residence from afar, Pickering further remarked, "Smoke from the house could be seen for miles.'

Though the cause of the fire is still under investigation by the insurance underwriter, Lukas guesstimated, "There's probably over \$100,000 worth of


