The current state of Lake Seminole

The subject this week is Lake Seminole, 37,500 acres claimed to be at the Florida/Georgia line. Each time we go out, it's to a different section of this lake, and/or through the connecting waterways. We're very disappointed in the Army Corps each time we've been out since Hurricane Michael. The last cruise was from Cypress Pond, to Fish Pond Drain, out to the main lake, then east towards the Flint River, taking a left into the Sealy's Point channel heading towards land, then right towards Spring Creek. Up Spring Creek, we took a left into Grassy Pond and back to Cypress Pond.

During this cruise we noticed many channel markers missing.

Ok, take boaters not familiar with the lake, then imagine them trying to

stay in the channels to avoid stumps. As they go through a port and starboard post it gets confusing. Ahead is one post with the other missing. Maybe they fail to notice the color marked on that post, causing them to have problems deciding which side of that post should they go.

Well, an experienced boater would have noticed as to whether the post was red or green, making it easy for them to decide.

As we traveled it was noticed, some didn't know what to do and went to the wrong side. Grassy Pond to Cypress Pond have some very shallow, narrow channels connecting the small lakes. Those channels still have trees down in them. It appears that locals have trimmed just enough for boats to get by. But let me tell ya, in some areas, those limbs do scrape, with overhanging limbs hitting the tops when up. In many channels, we found it necessary to reverse the outboard to clear the prop of vegetation.

That's a big problem for larger boats traveling the marked channels that are narrow. Several would come alongside to pass, then accelerate full speed before becoming clear of our vessel. That definitely rocked our 18 foot pontoon boat, and almost washed us into a channel marker pole once.

We're beginning to believe weekends are not a friendly time to be on the lake.

Remember, the first thing repaired after Hurricane Michael was the carp gates. I'm thinking safety first, clearing channels and replacing markers would have been the highest priority.

Who did we feel sorry for last weekend? Those who were trying to fish. See you outdoors...

Sign up for social-distancing paddle trips

In an unexpected twist to the COVID-19 pandemic and resulting economic downturn, at least one business sector is booming—the outdoor recreation industry and especially paddlesports.

At a time when team sports and other group recreation activities have been cancelled, recreation enthusiasts appear to be turning to the great outdoors — a place where the risk of the spread of the COVID-19 virus is considered less likely.

"It's unconstrained demand right now," said Don Meredith, director of product and marketing with Confluence Outdoor, maker of Dagger, Perception, Wilderness Systems and other brands of canoes, kayaks and paddleboards. "We can't make it fast enough."

In fact, while other manufacturers have been slow to start up or have downsized their work force, Meredith said Confluence's U.S.-based manufacturing facilities are scrambling to return to production and even hire new workers to meet the demand.

While brick and mortar shops closed during the

shutdown, purchases made online and through retailers offering delivery and curbside pick up have ushered in a boom for makers of person-powered vessels..

Cedar Creek Outdoor Center, a paddle sports retailer based in Dallas, Georgia which relies heavily on online sales and implemented a curbside pick up option, has seen its sales skyrocket.

"We've sold more boats in the first five months of this year than we did all of last year, and most of that has been since February" said owner James Lossick. "Sales of accessories are up 350 percent."

Industry observers attribute the rise in sales to a number of factors. With team sports shut down and many gyms and fitness centers closed or under strict social distancing guidelines, people are seeking new recreation opportunities. And with vacation plans altered, many are looking to "COV-ID-19-safe" activities they can enjoy near home.

Meanwhile those working at home, furloughed or not working at all have more free time and are seeking inexpensive and safe ways to recreate outdoors.

And, there's the "carpe

diem" factor that retailers have heard repeatedly during the pandemic.

"It's a wake up call," said Meredith. "People have taken a step back and looked at life and realized there's just that one today. If there's anything I want to do I better do it now."

While paddlesports sales are booming, those offering water sports adventure opportunities have been forced to alter their business models to ensure safe paddling.

Georgia River Network (GRN), a statewide river advocacy organization that runs multiple group paddle trips each year, was forced to cancel its annual weeklong river journey known as Paddle Georgia originally scheduled for June 20-27. Considered the largest weeklong canoe/kayak camping adventure in the country, it attracts more than 300 people each year.

Instead, the organization has developed a series of paddle trips that incorporate social distancing protocols.

"In group paddle trips, the greatest risk for transmitting the virus is during shuttles in which participants are together inside a van or bus," said Joe Cook, Paddle Georgia Coordinator. "Our paddle trips this summer eliminate the need for shuttles."

GRN has planned four Paddle-Bike Hidden Gem river adventures in which participants bicycle rather than ride in shuttle buses or vans. The paddle and rides range from six miles to 14 miles and begin July 25 with a six-mile bike and six-mile paddle on the Etowah River near Cartersville.
