## Residents asked to sign petition in support of **U.S. Highway 84 four-lane project**

CHOCTAW Co. - Area residents are being asked to add their voices to those pushing for the four-laning project on U.S. High-

Efforts are being put in place a petition asking state officials to move forward with the project that would provide a four-lane highway through the southern portion

of Choctaw County.

Ala. Representative Brett to gain thousands of signatures on Easterbrook, who represents Dis-65 including Clarke, Choctaw, and Washington counties, has been pushing the state to commit to the project. Easterbrook

said in a recent interview that he intended to continue to advocate for the four-laning of the highway through Choctaw County to the state line in Mississippi, where the highway is already four-laned. He

#### **Pouncey to** speak at **Chamber event**

BUTLER -- The new president of Coastal Alabama Community College will be guest speaker for the Choctaw County Chamber of Commerce's annual Pancake Supper on March 12.

Warren Craig Pouncey, who took the position with CACC last fall, will be speak to attendees at the event, which will be held at the Choctaw County Senior Citizens Center, at 112 Tom Orr Drive in Butler. The event is set to begin at 5:30 p.m. and is open to all Chamber mem-

Pouncey is the former Superintendent of Jefferson County Schools and served in several capacities with the Alabama State Department of Education, including Chief of Staff, Deputy State Superintendent and Assistant State Superintendent of Administrative and Financial Services and Director of Administration and Finance. He was appointed to the CACC position by the Alabama Community College System board of trustees on September 11 and took the position on October 1.

### New nursing home ownership looking forward to future

BUTLER – "There is a fresh new vision for this place," said Leigh Ann Jenkins, Marketing Transition Specialist for what is now Choctaw Health and Rehab.

New ownership is now in place for the former Blue Ridge Willow Trace Nursing Home, and leaders at the facility say that the future looks bright.

The new ownership comes after previous owners, Blue Ridge Healthcare, saw financial difficulties at the corporate level. Blue Ridge gained ownership of the Butler nursing home in 2017.

The facility is now owned by former Northport resident Shalom Lerner, who recently purchased six Blue Ridge facilities, with each facility independently owned. The transition to the new ownership took place on December 16.

"This family has been in the long-term care business for a long time," Jenkins said. "He is a licensed nursing home administrator with experience in the business. He is involved and hands-on in this transition."

Jenkins said that, while the nursing home was never in danger of closure, the new ownership will

bring a new vision for the facility. "I'm not going to take a position promoting a place that I don't believe in," said Jenkins, who works as a liaison between the community and the nursing home. "There may have been shaky ground in the past, but the nursing home is coming back stronger."

Jenkins said that the nursing home, which has been

## Tornado takes life in **Marengo County**

#### River remains above flood stage

BUTLER -- Choctaw County was spared from much of the predicted severe weather last Thursday, but other parts of the region were not so lucky.

A Marengo County woman was killed when an EF1 tornado destroyed her mobile home in the early morning hours on February 6. The body of Anita Rembert was found in the debris of the home, located on Highway 43 south of Demopolis. Her husband was also injured, but two others who were in the home at the time were not harmed

The tornado was one of at least two that were confirmed in

Alabama during the storm system. An EF0 storm caused damage in

Helena, in Shelby County. An EF2 storm also hit the Choctaw Area Boy Scout Council's Camp Binachi in Lauderdale County, Mississippi on Wednesday. According to reports, the camp, which is used by scout troops throughout East Mississippi and West Alabama, suffered significant damage.

The National Weather Service issued a list of watches and warnings that extended into Mississippi and Alabama during the storm system's progression through the Southeast. Predictions included strong thunderstorms, heavy rainfall, and potential tornadoes for
