

Douglas County Board declares a state of emergency

By Kendra Hennis The monthly meeting of the Douglas County Board was called to order on Wednesday, March 18 at 9 a.m.

The board began the meeting with a presentation from their IT Specialist, Jason, on how the board will do their meetings moving forward. They hope to minimize the number of people who need to be at a meeting by recording the meetings on Zoom, and then uploading them to the website. They are also looking at live streaming options. The board hopes to recieve feedback from

this meeting so they can make adjustments for the next meeting. Mr. Mikeworth asked if this procedure would also be followed for the subcommittee meetings and Mr. Munson said that they would. Munson noted that "there is a learning curve, but we're trying to stay ahead."

The board then approved the local agency agreement for federal participation for Cronus, section 13-000106-00-PV. This was necessary because the Douglas County Board entered into a Local Agency Agreement for State Participation for construction of County Road 750 E and 1050 N in the Douglas County Board revise support of Cronus infrastructure improvements, as per the State of Illinois Department of Transportation on August 28, 2015. The agreement was executed by the Illinois Department of Transportation on August 28, 2015. The agreement was for an amount of \$5,688,200 (state funds) for the proposed roadway improvements. Since the total cost of this section of work is \$1,000,000 the original agreement is only valid for five years from the date of execution by IDOT. The Illinois Department of Transportation requested that

the ending date of the agreement, extending it to August 28, 2024.

The board also approved an amendment to extend local agency agreement for state participation for section 13-00106-02-PV. This was necessary because the Douglas County Board entered into a Local Agency Agreement for State Participation for preliminary Engineering Services for the Cronus infrastructure improvements, as per the State of Illinois incentive package for the proposed fertilizer plant on February

primary election. There were high reported numbers of absentee and early voters. Most ballots have been counted, with the 14day period available for ballots still coming in. County Clerk Judi Pollock considers the day a success though noting "I expected a really low percentage, maybe 10, so 30 was really high. The judges and voters were all comfortable with the sanitation measures we had put in place. All things considered, I am pleasantly surprised."

Donald Trump and Joe Biden

Peggy Hubbard led the Republican race for Senator with 823 votes and Richard Durbin received 744 winning the Democratic side.

For the Congressional race for Representative, on the Republican side, Mary Miller leads the 15th District spot with 55 percent of the vote. For the Democrats, Erika Weaver received 60 percent of the vote. For the delegates, Natalie Phelps Finne leads the Democrats with 454 votes and Thomas Chapin Rose leads the

Republicans with 2,451 votes.

iact emergency measures Ы

The Villa Grove City council met on Friday March 20 at 6 p.m. for the specific purpose of creating a pair of ordinances regarding emergency procedures in response to the current COVID-19 pandemic. Ordinance

granted the city administrator the power to conduct city business, including making payments in excess of the allowed amount without Council approval.

Ordinance number 2020-2020-MC04 MC05 was created to allow emergency meeting procedures in order to allow for the City Council to hold their meetings electronically.

Finally, in response to the current pandemic, Mayor Cassandra Eversole Gunter declared a state of emergency for the city of Villa Grove.

The Mayor and council approved all actions unanimously. The mayor's declaration as well as the ordinances can be read in their entirety online.
