Sidney Village Board Swears in New Trustee and **Adopts New Ordinances**

September 8 Village of Sidney Board of Trustees Meeting Coverage - by Ann Rhoton SCCT News Correspondent

The Village of Sidney Board of Trustees met on Tuesday, September 8 in the Sidney Community Building meeting room at 7:00 p.m. The meeting was live streamed on Facebook and Village of Sidney President Jason Arrasmith brought the meeting to order at 7:01 p.m. following the recitation of the pledge of allegiance by all in attendance.

Village of Sidney President Jason Arrasmith asked if there was any public comment and was told that there was. Individuals in attendance at the meeting providing public comment were asked to wait in the buildings entryway, were called in individually, and left after providing comment in order to limit the number of people in the meeting room to adhere to social distancing guidelines.

Two gentlemen were in attendance at the meeting to ask if they could divide an 11 ½ acre property in to two properties on which each of them will build a house. The property is located northeast of the Village of Sidney within the 1.5 mile jurisdiction. They explained that Champaign County had told them that they needed Village of Sidney approval as the property is located within the village's 1.5 mile jurisdiction.

The gentlemen were told that their attorney needed to work with the Village of Sidney attorney to have paperwork written up that would include the changing of the property to residential and plans of what they wanted to do with the property so that the board could consider approval at the Monday, October 5 Village of Sidney Board of Trustees meeting.

The gentlemen noted there is expense associated with having the paperwork written up, asked the board if they would approve the dividing of the property, and were told that none of the board members were against the dividing of the property, but that they needed to get the proper paperwork completed.

Village of Sidney Board Trustee and Public Property Chair Tyler Bickers sent a text with Village of Sidney Attorney Marc Miller's phone number to one of the men so they could make contact and the gentlemen thanked the board for their time.

Cathy Thomas addressed the Village of Sidney Board of Trustees concerning the placement of political signs and asked whether they could be placed in the Village of Sidney right-of-way. Village of Sidney President Jason Arrasmith told her that the Village of Sidney does not have any set rules in place concerning the placement of political signs and that she is welcome to place them in the Village of Sidney right-of-way.

Village President Jason Arrasmith asked trustees to review the Monday, August 3 regular and executive (closed session) meeting and Wednesday, August 19 special meeting minutes and for a motion to approve them as written if they so choose. The minutes were approved following a motion from Trustee Leroy Schluter and a second to the motion by Trustee Bret Harris.

Village of Sidney President Jason Arrasmith began his comments by making a motion seconded by Village of Sidney Trustee Tyler Bickers to appoint Village of Sidney resident Donna Hooker to the office of Village of Sidney Trustee to fill the unexpired term of former Village of Sidney Trustee Mark Catron. The motion carried.

Donna Hooker was sworn in by Village of Sidney Clerk Maggie Fish and Village of Sidney President Jason Arrasmith welcomed her to the Village of Sidney Board of Trustees and stated that she will be in charge of finance.

President Jason Arrasmith continued with his comments by asking for an update on the new Village of Sidney

Hall located at 211 East Main Street from project manager Robert Tincher from Hillside Development Group, LLC.

Mr. Tincher reported that he would like to do a walkthrough of the building with President Arrasmith and Trustees Tyler Bickers and Dan Gadeken around September 17 or 18.

President Arrasmith reported there had been a \$4,153.36 change order that he wanted the Village of Sidney Board of Trustees to approve because he was not comfortable with approving it himself.

Discussion concerning the change order took place between the board and Mr. Tincher with some trustees expressing their unhappiness with the number of change orders stating it is their responsibility to handle Village of Sidney monies responsibly. Payment of the change order was approved following a motion from Trustee Dan Gadeken and a second by Trustee Tyler Bickers.

Carson Willard updated the board on his Eagle Scout project by reporting that he was still in the fund raising phase and that he had raised

\$280.00 for the project. He additionally reported that he was planning to work on his Eagle Scout Project on Saturday, September 19. A motion from Trustee Bret Harris seconded by Trustee Dan Gadeken for the Village of Sidney to spend not to exceed \$250.00 to help Carson with expenses on his Eagle Scout project at the Village of Sidney west end of town entryway carried.

Sidney American Legion Post 433 Commander Bill Hensch, Post 433 Adjutant Bill McLane, Post 433 Finance Officer Dannie Cline, and Post 433 Judge Advocate Susan McLane were called into the meeting room to discuss Ordinance #2020-10 approving the Village of Sidney sale of the Sidney Community Building/Sidney Village Hall located at 221 South David Street to the Sidney American Legion Post 433 for one dollar and to approve the contract between the Village of Sidney and the Sidney American Legion Post 433 for the sale of the building to the Sidney American Legion Post 433 under President Arrasmith's comments.

President Arrasmith noted

that the selling price of \$10.00 needed to be changed to \$1.00 in two places within the con-

A motion from Trustee Leroy Schluter seconded by Trustee Bret Harris to approve Ordinance #2020-10 approving the sale of the Sidney Community Building/Village of Sidney Hall located at 221 South David Street to the Sidney American Legion Post 433 for one dollar and to approve the contract between the Village of Sidney and the Sidney American Legion Post 433 to sell the Sidney Community Building/Sidney Village Hall located at 221 South David Street to the Sidney American Legion Post 433 with two price changes from \$10.00 to \$1.00 within the contract carried following a review of the documents by the Village of Sidney Board of Trustees and the Sidney American Legion

Jessica D. Jenkins is the Vice President of Collections and Storytelling at Minnetrista, a museum and gardens in Muncie, IN. In her role she directs and leads activities related to historic resources, including the acquisition, use and management of the museum's collection. In addition to oversight of the collections management department, Jenkins also leads the museum's research and storytelling efforts, including the development and creation of exhibitions on Minnetris-

High School in Broadlands, IL. Throughout her time as an elementary, junior high, and high school student at Heritage, Jenkins was active in a variety of activities, including the East Central track & field team, the Heritage Hawks Girls' basketball team, scholastic bowl, band and choir, and theatrical productions. Jenkins was a also member of the National Honor Society, a recipient of the Heritage High School Band Director's Award, and a participant in the Worldwide Youth in Science and Engineering competition. Jenkins holds a Bachelor of Arts in History from Quincy University, Quincy, Illinois, where she was the recipient of the Quincy University History Department's Owen J. Blum O.F.M. Award for Scholarly Achievement in History. In 2010 she received a Masters of Arts in Public History from Central Connecticut State University, New Britain, Connecticut, and was awarded the Department of History's Graduate in Public History Award. Ms. Jenkins has worked in museums and cultural institutions for more than a decade, specializing in collection and exhibition curation. Before assuming the role of Vice President of Collections

and Storytelling at Minnetrista, she served as the organization's curator and was then promoted to Director of Collections. During her career, Jenkins has worked with organizations ranging in size from a staff of two to a staff of two-hundred, including full and part-time curatorial and collections management roles at the Litchfield Historical Society, Litchfield, CT; Indiana Historical Society, Indianapolis, IN; Indiana State Museum, Indianapolis, IN. She has also consulted with organizations such as the Sharon Historical Society, Sharon, CT, and the Greenwich Historical Society, Greenwich, CT. In addition to developing history and fine art exhibitions, Jenkins has worked extensively with educators, developed and executed environmental monitoring programs, overseen the maintenance of historic structures, and executed collections management, registration duties, and policy development. She has authored publications on topics ranging from woman suffrage to World War I poster art, including the 2015 publication, House of Worth: Fashion Sketches, 1916-1918.
