Sealed Bids for the construction of the Town of Kershaw Water Pipe Replacement, RIA Grant # R-21- 1272 will be received, by the Town of Kershaw at their office located at 113 S. Hampton St., Kershaw, SC 29067, until 2:00 PM local time on August 24, 2021, at which time the Bids received will be publicly opened and read. The Project consists of 5256 LF of 8" main, 69 LF of 6" main, 150 LF of 2" main, 8 fire hydrants, 40 LF of 16 inch Jack and Bore, 28 service connections, valves, fittings and various appurtenances.

Bids must be enclosed in a sealed envelope, addressed to Mitch Lucas, Town Administrator, Town of Kershaw, 113 S. Hampton St., Kershaw, SC 29067.
