Outstanding Natural Area Family Day at Jupiter Lighthouse

Jupiter Inlet Lighthouse & Museum (JILM) is celebrating the 13th Anniversary of the Jupiter Inlet Lighthouse Outstanding Natural Area (ONA) on May 8. Thirteen years ago,

the property became one of only three such sites in the entire United States. At the same time, the Jupiter ONA became part of the National Conservation Lands - the first and only

unit east of the Mississippi River within the Bureau of Land Management. This Congressional designation protects and preserves the rare history and natural habitats of this unique area

in perpetuity. To help celebrate ONA Family Day, children will receive free admission between 10 a.m. and 2 p.m. and a Lighthouse Activity Backpack containing a

'Nature Hunt' and Lighthouse binoculars, while supplies last. Families will be able to visit the Museum, Tindall Pioneer Homestead, Keeper's Workshop exhibit, and

historic grounds, and climb the Lighthouse. A special 'Nature Hunt' has been designed just for the occasion and the backpack includes everything families will need to discover the native flora and fauna while exploring the Outstanding Natural Area. The Bureau of Land Management will provide Jr. Park Ranger Booklets and crayons for the Lighthouse Activity Backpack and a fun onsite activity for children.

The Bureau of Land Management will be giving out America the Beautiful Every Kid Outdoors park passes to fourth (and fifth) graders. The pass allows the student and the entire vehicle, or up to three guests where individual fees are charged, into Federal Recreation sites such as National Parks, National Wildlife Refuges, National Forests and National Monuments, among others.

Visitors should bring sunscreen and dress for the weather. Program attendees are also invited to climb the Lighthouse: Children must be a minimum of 48" tall to climb, and be accompanied by an adult. For your safety, masks are required at this event and social distancing should be observed between other individuals or family groups. Pets, food, drink and coolers are not permitted at this event.

General Admission for May 8 at the Jupiter Inlet Lighthouse & Museum is \$12 for adults; \$10 for Seniors & US Veterans; Free for children 18 and under, Lighthouse Members and active-duty US Military.
