Free Meals for Students During the Summo

Palm Beach County School Food Service will continue to distribute free meals during the summer, beginning on Tuesday, June 22 at select locations. More distribution locations will be added on Monday, June 28.

There is no food distri-

bution during the week of June 14, and food will not be distributed from August 1-9. Regular meal service for students at school will begin again with the start of the 2021-2022 school year on August 10.

All sites with summer school or summer pro-

grams will be open for children (or parents/guardians of the children), 18 years of age and younger to receive a breakfast and/or lunch for free each day.

Distribution times and

distribution for breakfast and lunch will be providing both meals at that time.

A child does not have to be present to pick up meals. However, one of the following forms of identification is required to receive meals at the food distribution sites: Student ID Badge, Student Barcode Letter (that can be found in the child's student portal), Passport, Birth Certificate, or Library Card.

The adult picking up the meals can also bring a picture that has themselves and the children for whom they are picking up food, in the photo. For the safety of the staff, facial covering or mask is required when picking up meals at any school food distribution site.

Meals may contain allergens. Adults picking up the food are asked to be vigilant and ensure they do not take food if allergies may be a concern. Food should be refrigerated or discarded if not consumed upon receipt.

PBC Rent/Utility **Asstistnce Portal Open**

The Palm Beach County Community Services Department (CSD) has opened its online portal for emergency rent and utility assistance. Renter households with at least one individual who has experienced a loss of income either directly or indirectly due to COVID-19 may qualify for assistance. Households must be at or below 80 percent of the Area Median Income to be eligible. Individuals who qualify for unemployment, can demonstrate a risk of homelessness or housing

Electric assistance is also available to households that have not been financially impacted by COVID-19.

All applicants impacted financially by COVID -19 must present the following documentation in order to apply for rental and/or relocation assistance:

- Evidence of COVID-19 direct or indirect impact
- Evidence of risk of homelessness or housing

- ber for all household members. Applicant will have to provide copy of social security card. Household members may need to provide copy if deemed necessary by the Case Manager.

Rental assistance may be paid up to three months in advance and income must be recertified for each three (3) month period.

For rental assistance, landlords must be regis $tered\,as\,vendors\,with\,Palm$ Beach County. Utility assistance is for electric, water, gas, sewer, trash removal and energy costs for eligible rental households only.

Applicants must submit the correct information along with all required documentation to expedite approval. Applications will be prioritized for clients who are below 50 percent AMI, facing evictions and currently unemployed.

In-person assistance and mobile outreach are available for individuals

- Lack computers or internet connection; or,
- Lack the skills needed to use a computer; or
- Have language barriers or developmental disabilities; or
- · Are facing other barriers that prevent them from accessing the online application portal for rental assistance.
