## PRESIDENT WILSON CALLS FOR THANKS

The President, in this annual Thanksgiving Day proclamation, calls upon the people to give thanks to God, the Creator. Thanks should be offered for the return of the great army of freedom. It follows:

“The season approaches when it behooves us to turn from the distractions and preoccupations of our daily life, that we may contemplate the mercies which have been vouchsafed to us, and render heartfelt and unfeigned thanks unto God . for His

manifold goodness. “This is an old observance of the American people, deeply imbedded in our thought and habit. The burdens and the stresses of life have their own insistence.

“We have abundant cause for thanksgiving. The lesions of the war are rapidly healing. The great army of freedom which America sent to the defense of liberty, returning to the grateful embrace of the nation, has resumed the useful pursuits of peace, as simply and as promptly as it rushed to arnjs in obedience to the country’s call. The equal justice of our laws has received steady vindication in the support of a law-abiding people against various and sinister attacks, which have reflected only the baser agitations of war, now happily passing.

“In plenty, security and peace, our virtuous and self-reliant people face the future, its duties and its opportunities. May we have vision to discern our duties the strength, both of hand and resolve to discharge, them and the soundness of heart to realize the truest opportunities are those of service.

“In a spirit, then, of devotion and stewardship we should give thanks in our hearts, and dedicate ourselves to the service of God’s merciful and leving purposes to His children.

“Wherefore, I, Woodrow Wilson, President of the United States of America, do hereby designate Thursday, the twenty-fifth day of November, next, as a day of thanksgiving and prayer, and I call upon my countrymen to cease from their ordinary tasks and avocations upon that

day, giving it up to the remembrance of God and His blessings, and their dutiful and grateful acknowledgment.”

Unclaimed Property is a financial asset that is unknown or lost, or has been left inactive, unclaimed or abandoned by its owner. The most common types of unclaimed property are dormant bank accounts, unclaimed insurance proceeds, stocks, dividends, uncashed checks, deposits, credit balances and refunds. Unclaimed property also includes contents from abandoned safe deposit boxes in financial institutions. Unclaimed property assets are held by business or government entities (holders) for a set period of time, usually five years. If the holder is unable to locate, re-establish contact with the owner

and return the asset, it is reported and remitted to the Florida Department of Financial Services, Division of Unclaimed

## Ordinance 2021-18 and Ordinance 2021-19

**PLEASE TAKE NOTICE** that the City of Lake Worth Beach’s City Commission will conduct a virtual meeting with limited in-person attendance per the Centers for Disease Control and Prevention Coronavirus Disease 2019 (Covid-19) Guidance at 7 North Dixie Highway, Lake Worth Beach on **December 7, 2021 at 6:00 pm**, or soon thereafter, to consider a request on second reading/adoption submitted by the City of Lake Worth Beach for a Future Land Use Map (FLUM) amendment (Ordinance 2021-18) and a **Zoning Map amendment** (Ordinance 2021-19) for the properties located at 706 South H Street and 710 South H Street with Property Control Numbers (PCN) of 38-43-44-21-15-223-0070 and 38-43-44-21-15-223-0060. The request is to change the existing FLUM designation from the Mixed Use - East (MU-E) FLU to the Public (P) FLU and to rezone from the Mixed Use – Dixie Highway (MU-Dixie) zoning district to the Public (P) zoning district.

**Affected parties**, as defined in Section 23.1-12 of the Lake Worth Beach Code of Ordinances, who are interested in participation must notify the City of their status **at least five (5) days before** the first reading of the City Commission. Failure to follow the process will be considered a waiver of the right to participate as affected party in the hearing, but does not preclude the party from making public comment. Affected parties shall submit the evidence they wish the City Commission to consider a minimum of one (1) full business day prior to the date of the meeting Affected parties, whether individually or collectively and irrespective of the number of affected parties, shall have the right to request one (1) continuance provided that the request is to: address neighborhood concerns or new evidence, hire legal counsel or a professional services consultant, or is unable to be represented at the hearing. If a person decides to appeal any decision made by the Board, Agency, or Commission with respect to any matter considered at such meeting or hearing, he or she will need a record of the proceedings, and that, for such purpose, he or she may need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based (FS 286.0105). In accordance with the provisions of the American with Disabilities Act (ADA) this document may be requested in an alternative format. Persons in need of special

accommodation to participate in this proceeding are entitled to the provision of certain assistance. Please call 561-586-1662 no later than five (5) days before the hearing if this assistance is required.
