Notice is hereby given to all owners of real property located within the boundaries of the Northern Utility Service Area in the Town of Lake Clarke Shores that the Town intends to use the uniform ad valorem method, as set forth in Section 197.3632, Florida Statutes, for the levy, collection, and enforcement of non-ad valorem special assessments as may be levied by the Town for water and sewer facilities and related costs.

The Town Council will hold a Public Hearing on December 14, 2021 at 6:30 PM. at Town Hall, located at 1701 Barbados Road, Lake Clarke Shores, Florida 33406, the purpose of which is to consider the adoption of a Resolution authorizing the Town of Lake Clarke Shores to use, in accordance with Section 197.3632, Florida Statutes, the uniform ad valorem method of collecting non-ad valorem assessments for water and sewer facilities serving the Northern Utility Service Area within the Town. Such Resolution states a need for the levy of such assessments and will contain a legal description of the boundaries of the Northern Utility Service Area.
