1,845 items for food pantry

First grade collected 530, second grade 412, kindergarten 294 and preschool 164. Items donated by Rotarians and those deposited in boxes at Longhunters Coffee and Tea Co., City Hall, the office of Nancy Stearman, CPA, Community Trust Bank, Limestone Bank and Forcht Bank for three weeks totaled 427.

Under the supervision of the property valuation administrator or one of the deputies, any person may inspect the tax roll.

This is the January 1, 2021, assessment on which state, county, and school taxes for 2021 will be due about October 1, 2021.

The tax roll is in the office of the Property Valuation Administrator at 103 South 1st Street and may be inspected between the hours 8:00 AM and 3:00 PM during week days, and 8:00 AM to 10:00 AM on Saturday, May 8th and 15th.

Any taxpayer desiring to appeal an assessment on real property made by the PVA must first request a conference with the PVA or a designated deputy. The conference may be held prior to or during the inspection period. Due to COVID-19 crises, conferences may be held via video-conference, email, telephone, or fax. Documentation supporting your opinion of value will continue to be required.

After the conference with the PVA or designated deputy, any taxpayer still aggrieved by an assessment on real property may appeal to the county board of assessment appeals.

The taxpayer can appeal his assessment by filing in person or sending a letter or other written petition stating the reasons for appeal, identifying the property and stating the taxpayer's opinion of the fair cash value of the property.

The appeal must be received in the county clerk's office no later than one work day following the conclusion of the inspection period.

A taxpayer failing to appeal to the county board of assessment appeals, or failing to appear before the board, either in person or by designated representative, will not be eligible to appeal directly to the Kentucky Board of Tax Appeals.

Appeals of personal property assessments shall not be made to the county board of assessment appeals. Personal property taxpayers shall be served notice under the provisions of KRS 132.450(4) and shall have the protest and appeal rights granted under the provisions of KRS 131.110.

The following steps should be taken when a taxpayer does not agree with the assessed value of personal property as determined by the property valuation administrator.

(1) He/She must list under protest (for certification) what they believe to be the fair cash value of their property.

(2) He/She must file a written protest directly with the Department of Revenue, Office of Property Valuation within 30 days from the date of the notice of assessment.

(3) This protest must be in accordance with KRS 131.110

(4) The final decision of the Department of Revenue may be appealed to the Kentucky Board of Tax Appeals.
