

# **Romeo Elementary School Employee Terminated After** Lewd & Lascivious Arrest

On Thursday, January 14, 2021, Marion County Sheriff's Office (MCSO) Major Crimes detectives arrested Juvenal Gomez (DOB: 12/01/1962) for Lewd and Lascivious Conduct on a Romeo Elementary Student. On November 20, 2020, School Resource Officer, Hewett received Cpl. information that a student inappropriately was touched by a para-professional, Juvenal Gomez. The victim stated Gomez, while sitting beside her at a table, put his hand up her skirt. He also provided the student a blue "peso" (given to students for good behavior) that contained his personal phone number on it and the word "kitten". Due to the allegations, Marion County Public Schools Officials terminated Gomez on November 20, 2020, while MCSO detectives continued the investigation.

## **Man Out On Bond For Capital Sexual Battery Rearrested After Fleeing From Traffic Stop**

On January 8, 2021 Cpl. Eli Serrano conducted a traffic stop on a 1988 blue Ford Bronco for running a stop sign. The driver, later identified as Allen Buford, pulled over and handed Cpl. Serrano an ID card stating he lost his Driver's License. As Cpl. Serrano went back to his car to check the validity of his license, Buford fled from the stop.

After a brief pursuit, Buford pulled over and exited his vehicle grabbing a gun and holding it by his side. Buford continuously asked Cpl. Serrano to kill him stating his life was over. Cpl. Serrano was able to convince Buford to put the gun down; however, he turned to walk away from Cpl. Serrano and was tazed. He was arrested for Fleeing/Elude, Display of a Firearm during a Felony, DWLSR and Carrying Concealed Weapon. He was transported to the Marion County Jail.



Major Crimes Detective Castellano responded to the hospital and was advised the infant was suffering from a traumatic injury resulting in a brain bleed and bruises on her body. The infant victim remains in critical condition.

Detectives interviewed the victim's mother, who revealed that Bairan had been with the infant for several hours before waking her up to the victim being unresponsive in his arms. Detective Castellano then spoke with Bairan, who stated the victim had been whiny and fussy all day, but otherwise was behaving normally. He advised he had fallen asleep with the victim and when he awoke she was no longer responsive. Bairan could not provide any explanation for the victim's injuries and a walk through of the incident location did not reveal any explanation for the injuries the infant victim sustained. The medical examination of the victim revealed abusive head trauma consistent with violent shaking. When presented with these findings, Bairan refused to discuss the incident further with detectives.

Bairan was arrested for Agg. Child Abuse and cocaine and prescription pills were located on his person. Bairan was also on probation for Aggravated Assault with a Deadly Weapon and Impersonating a Police Officer. He was transported to the Marion County Jail with no bond.
