Motorcyclist dies in crash on Ebenezer Road

Staff Report

A crash involving a motorcycle and a Jeep on Ebenezer Road claimed the life of the motorcyclist.

The accident happened at about 9:45 a.m. on Saturday, March 20, on Ebenezer Road between Love Road and Valentine Road, according to Deputy Lenwood Genous, the investigator for the Sheriff's department.

When the crash occurred, the motorcycle was traveling north towards Lexington and the Jeep was traveling south.

The motorcyclist, who was killed instantly at head-on-collision. has been identified as 73year old Messena Jones of Bentonia. The driver of the Jeep (a minor) survived with minor injuries. The accident remains under investigation by the Sheriff's office.




