thanks to the \$300 per week federal benefits stipend. Plus, he said, cutting the benefits off without taking other steps could harm people who are legitimately unemployed.

He said many states have increased their minimum wage to as much as \$15 per hour. If it was increased to \$9 or \$10 an hour in Mississippi, Johnson said it would help low wage workers and boost the economy.

Rep. Chris Bell, D-Jackson, said, “It’s very unfortunate to hear about ending the unemployment benefits for Mississippians who are currently out of work.”

“I don’t know of a single person who would rather receive these benefits than find meaningful employment,” Bell said. “The extension of unemployment benefits should not expire.” Mississippi’s unemployment

ment for March was 6.3%, higher than the national average of 6% and up from 6.1% in February. Overall, Mississippi’s number of jobs remains down by 3% from last year.

Mississippi for March ranked last, at 56.1%, in workforce participation — a trend that predates the pandemic — and it ranks last in median household

income at \$45,081, also a trend predating COVID-19. Mississippi’s state economist recently reported that the state is forecast to see a major economic rebound in 2021, including job growth of 1.8%, the highest annual increase since 1998. He noted that much of that growth would be due to federal COVID-19 stimulus spending.
