Holmes County Sheriff Willie March said that Moore has a history of violence and has served time for aggravated assault.

According to Sheriff March, the vehicle in which they were traveling was found abandoned in Duck Hill near the Interstate 55 exit.

On Thursday, November 18, the Mississippi Bureau Investigation (MBI), of which has been assisting the Sheriff's office in the case, said that Miss Andrews had been located and found safe. She was found just after 6:30 p.m. in Carroll County.

The suspected kidnapper has been arrested and is in custody.
