COVID-19 **UPDATE**

54 new COVID-19 cases reported locally in past thirteen days

The daily local COVID-19 case count increase is posted on the *Donalsonville News* Facebook page

A vaccine for the COVID-19 may now be a reality; however, until it is administered wide spread, the continued risk of the virus also remains a grim reality for Seminole County citizens and beyond.

Seminole County's positive COVID-19 case numbers continue their daily rise, as local medical personnel, first responders, and residents 65 years and older begin the process of receiving the long awaited COVID-19 vaccine.

Fifty-four new positive cases have been reported locally in Seminole County over the past thirteen days. As of presstime on Wednesday, January 13 twelve new cases were reported locally in the past 48 hours, and 41 additional cases have been reported for Seminole County by the Georgia Department of Public Health since this time last week.

Since March of 2020, Seminole County has been recorded with 618 positive cases, twelve of which, sadly, have resulted in Coronavirus related deaths.

As of Wednesday, January 13, since March 2020, there have been 648,694 cases of COVID-19 statewide - out of 6,183,753 people tested - and 10,444 deaths reported to state health officials. Since this time last week, 238,753 additional Georgia residents have been tested, with 51,486 of them testing

Patience urged amid slow **COVID-19 vaccine rollout**

Local providers are struggling to administer COVID-19 vaccines in Georgia as health clinics have been swamped with requests for doses since Gov. Brian Kemp expanded eligibility to those 65-years and older.

The deluge of vaccine seekers came as the General Assembly grappled with the highly infectious virus on Tuesday. A top lawmaker in the Georgia Senate announced he tested positive just two days into the 2021 legislative session in Atlanta.

Georgia is currently being shipped around 120,000 doses of

Georgia COVID-19 vaccine locator tool launched

Georgia has added a new tool to find COVID-19 vaccine providers as the state continues its vaccination distribution plan.

The new COVID-19 vaccine locator tool is aimed at helping people find the nearest vaccination site to them - anywhere in the state.

Currently in phase 1 of the vaccine distribution plan the Georgia Department of Public Health announced on Sunday that the agency had launched its own "COVID vaccine locator" to allow users to find vaccine providers in their communities.
