Continued from page 15 Tower Lease and License Agreement set to expire on April 4, 2021. The agreement provides for four (4) successive five year-term renewals. City Manager Hicks stated that this would be the first renewal under these terms. In any event, Georgia Law provides that the contract terminates at the end of each calendar year and automatically renews on January 1st of each calendar year during the term of the agreement unless positive action is taken by the council to terminate the lease. The current lease rate is \$500 per month and is subject to a CPI adjustment upon renewal. CP Register made a motion to seek renewal of the Hornsby Cell Tower Lease and License Agreement set to expire on April 4, 2021. CP Smith seconded; motion carried.

City Manager Hicks then requested the approval of the 2021 LMIG Funding for the milling and resurfacing of East 2nd Street and resurfacing of 1st Street. City Manager Hicks stated that this would complete the downtown resurfacing east of South Wiley Avenue. The City will receive LMIG funds in the amount of \$42,962.38 to combine with available TSPLOST funds to complete the project. The milling and resurfacing of both East 2nd Street and 1st Street are on the original TSPLOST list. Total Project Cost totals \$184,000 with the breakdown as follows:

- 1st Street from South Tennille Avenue to South Wiley Avenue 0.20 miles-Resurfacing \$36,000
- East 2nd Street from South Tennille Avenue to South Wiley Avenue 0.08 Miles-Milling and Resurfacing \$148,000

City Manager Hicks stated that sidewalk work would also be incorporated into this project at the corner of South Wiley Avenue and East 1st Street. Depending on available funding, other streets might be able to be incorporated into this project as well. CP Smith made a motion to approve the 2021 LMIG Funding for the milling and resurfacing of East 2nd Street and resurfacing of 1st Street. Mayor Pro Tem Bond seconded; motion passed.

Next, City Manager Hicks requested the approval to work with the Chamber of Commerce to implement a year-round tree lighting project. City Manager Hicks stated that this is a component of the recent Rural Zone Designation. The cost is \$700 per tree (8 trees currently) for the installation, with material cost estimated at \$400-\$500 for the whole project. CP Register made

a motion to approve the implementation of a yearround tree lighting project with the Chamber of Commerce. CP James seconded;

motion carried. Communications Director Hatcher then gave an update on the eDonalsonville activities, along with the system's continued growth. Communications Director Hatcher also stated that he had recently been given an anticipated date of April to expect commercial deployment of the new frequencies to begin. This will allow eDonalsonville to increase capacity and provide coverage in areas outside of Donalsonville. Communications Director Hatcher stated that he is still waiting on further information of funding availability and application processes for increased broadband funding. The City of Donalsonville will pursue that funding to help with expansion of the eDonalsonville project. eDonalsonville is still waiting on Georgia Pacific to complete electrical installation at their plant. Billing to cover the incurred costs of the deployment will begin since eDonalsonville equipment has been installed since Summer 2020. Finally, Communications Director Hatcher discussed the completion of the Security Camera project in Donalsonville. The department is still waiting for Georgia Power to finish their review of the application for power to four locations within Donalsonville where cameras are already installed.

Next, Fire Chief King gave an update on the Fire Department, with review of the run summary from January. Chief King stated that the Donalsonville Fire Department had their first fire fatality since 2013 last night in the county. The department assisted the Spring Creek Volunteer Fire Department with extinguishing the fire. Lastly, Chief King stated that the Breathing Air Compressor had been completely installed and has been in operation for the past three

Police Chief Blue then stated that he had nothing new to report at this time.

Next, Public Works Superintendent Adams stated that he had nothing new to report at this time.

City Manager Hicks then gave an update on the following:

- (1) Process for Blighted Property Enforcement-As per the City Attorney, this is a summary of the process:
- City Manager may issue citations for violations and seek enforcement in City
- Property owner will be entitled to a hearing within 45

- Court could require repair or demolition within a reasonable time
- The owner would have 270 days to act on the Court's order
- The City may designate property that meets certain conditions by a Declaration of Public Nuisance to be blighted property, implement a community redevelopment tax incentive program and levy an additional tax on the property until the problem is cured.
- (2) SmartGov Permitting and Inspection Software: After research into permitting and inspection software the cost and software applications are as follows:
- Annual Subscription Cost
- Implementation and Training Costs \$22,569.00
- Annual Subscriptions costs are based on population and include the following:
 - Permitting, Inspections and Code Enforcement
