On June 6th, Nicola R. Miller, age 31, was picked up from Muscogee County for a probation violation warrant.

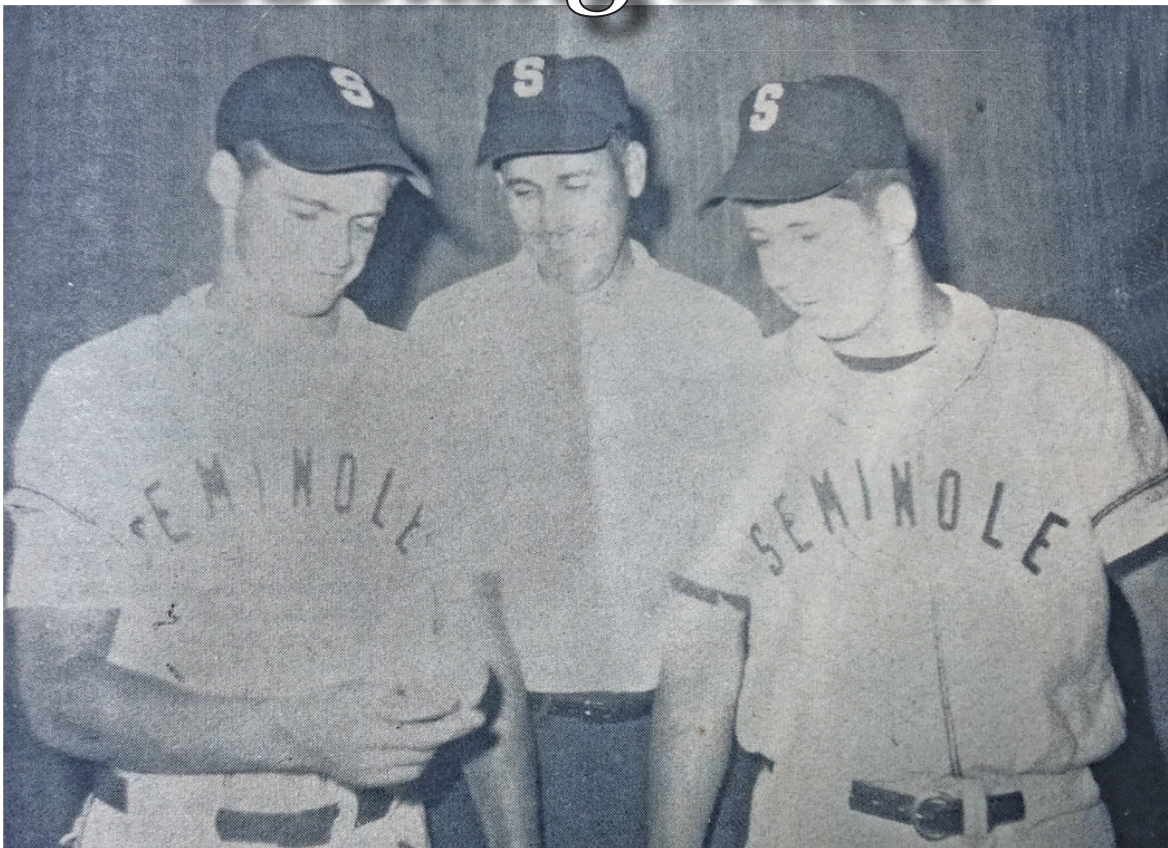
Three inmates were transported to Jackson State Prison. One inmate was picked up from Early County and then returned to Early County. An average of 51 inmates was housed in jail each day.

In addition, the Sheriff's Office handled 28 calls for Grady EMS, 3 for the first responders, and 1 for the coroner. They made 1 request for EMS mutual aid.

They handled 155 calls for Donalsonville Police Dept, 11 for Donalsonville Fire Dept, 4 for Iron City Fire Dept, 5 for Iron City Fire Dept, 3 for Georgia State Patrol, 17 for other law enforcement or emergency service agencies, and 8 others.
