(1) Proposed Retirement Program Changes: A survey/ poll will be sent on Wednesday, June 2nd, to determine the interest from employees on the level of participation in a proposed change in the current retirement system to provide for full retirement benefits and age 55 with 25 years of service. The current program is set at age 65 with 25 years of service. The change in the benefit will cost the City of Donalsonville an estimated \$40,786 per year. Current budget projections indicate the City would have to commit to sources of revenue that are not currently available to fund this change. Employee participation would require a minimum of 2% to 3% of the current pay to fund this change.

(2) Update on Traffic Light Request-GDOT: Received an e-mail from the Chief Engineer at GDOT regarding the requests for traffic light improvements at intersections with information related to our request as follows:

"Since that time, GDOT engineers have evaluated the operations at the intersection. GDOT's statewide traffic signal software allows us to monitor operations and performance of signals remotely. Analysis showed that there were some times a day when left turns at the signal were not clearing with each signal cycle, but also confirmed that the left turn volumes did not warrant a turn signal. The delay issues can be addressed by improving the signal timing and operations. Specifically, the following issues with the signal were identified and addressed:

• Side Street Detection: periodic faults on the side streets would cause those approaches to unnecessarily hold for extended periods, decreasing efficiency for the entire intersection. This would occur 30-40 times a day on average and has been eliminated. New vehicle detection will be installed in June and will fully resolve this issue.

• Green Time: By fixing the detection issues here, we were able to adjust time to cover actual queues on side streets without any negative impact to the mainline. Cycles where side street and left turn movements were over capacity dropped from 20% to 3-7%, on average. Approach delay per vehicle on the mainline did not have any increase as a result of this timing adjustment.

• Travel Time: At a higher level we were able to observe travel time through the system slightly decrease (7% decrease on average, so traffic is moving faster through the intersection).

We still see spots of demand, but they are brief and clear typically within a single cycle of the signal. The new vehicle detection equipment is ordered and scheduled for delivery later this month. The district will install once received. We will continue to monitor the signal. Please feel free to provide us feedback from what you are seeing and hearing as well. You mentioned a new truck stop development is planned in the future around the intersection. As volumes and demand increases, we can reevaluate the need for a left turn signal phase if needed in the future. Thank you and please feel free to contact me if you have any questions."
