**Thursday, April 15** - Chicken and noodles, mashed potatoes, three-bean salad, whole grain wheat, warm fruit crisp

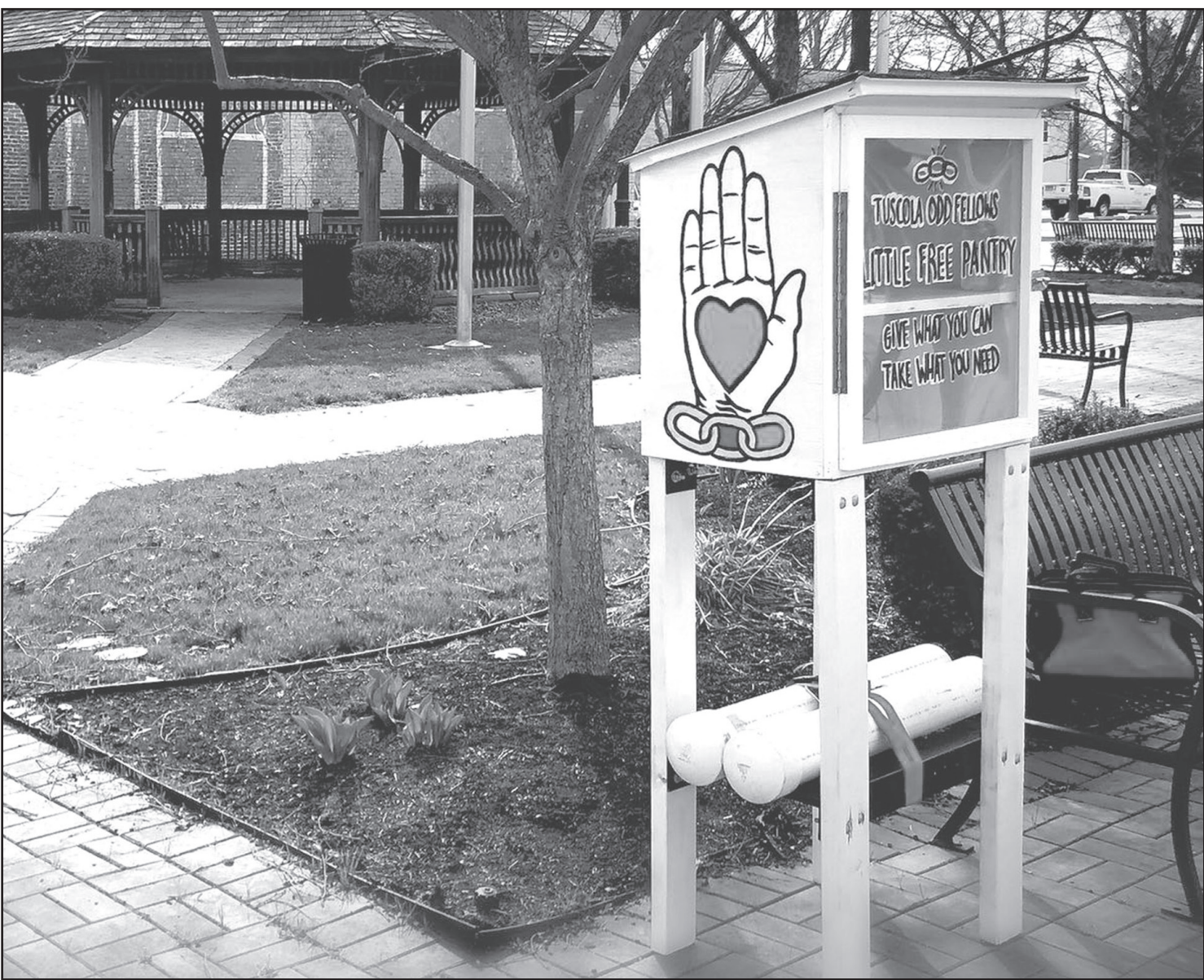
