### CRIMINAL CHARGES

Jose Puebla, 29, City, charged with a Class A misdemeanor in that in July 2021 he allegedly committed the offense of possession of firearm ammunition without FOID in that said defendant possessed firearm ammunition within the State of Illinois, being 9mm firearm ammunition, without having in his possession a Firearm Owner's Identification Card previously issued in his name by the Department of State Police under the provisions of this act.

Aldo Marquez-Garza, 28, Charleston, charged with a Count 1 Class A misdemeanor in that in July 2021 he allegedly committed the criminal offense of domestic battery in that said defendant knowingly without legal justification caused bodily harm to a family member of the defendant, in that said defendant hit them in the face causing pain. Jason C. Novak, 38, Onarga, charged with a Class 3 felony in that in August 2021 he allegedly committed the offense of violation of the Illinois Murderer and Violent Offenders Against Youth Registration Act in that said defendant, a violent offender against youth, and a person who lacked in a fixed residence or temporary domicile, failed to notify the Douglas County Sheriff's Office or any other law enforcement agency in Douglas County, within 48 hours of his presence in Douglas County.
