2021 Cardinals season ends

The Cardinals found an extra gear in September and their seventeen-game winning streak was the longest in team history. It was really something to rally around and it made for must-see tv for those few weeks. That's the good news. The bad news is that their reward for such a gallant run was a one-day playoff game against the Dodgers, which they lost in the bottom of the ninth. I did find one thing about the matchup that was interesting, however. The Dodgers used five pitchers in the game.
