Thursday, 4/8/21 – Baked ham, frosted sweet potatoes, rye bread served with butter or margarine, Brussels sprouts, fruit salad, and a half pint of milk.

Friday, 4/9/21 - Mostaccioli with meaty sauce, whole grain wheat bread served with butter or margarine, corn, creamy coleslaw, warm fruit cobbler, and a half pint of milk.

Monday, 4/12/21 - Sausage in gravy, biscuits served with butter or margarine, mini potato bakers, fruit juice, warm cinnamon buttered apples, and a half pint of milk.

Tuesday, 4/13/21 - Chili with beans, crackers, tossed salad with dressing packet, mandarin oranges, and a half pint of milk

in Homer. CONGREGATE MEALS ARE PICK-UP TO CARRY OUT ONLY AT THE PRESENT TIME.

Homer Peace Meal is served around 11:00 a.m. Monday through Friday in the Homer Village Hall located at 500 East Second Street in Homer. Home delivered meals are available Monday through Friday for seniors who qualify.

To reserve your spot call Peace Meal at 1-800-543-1770 by 12:00 p.m. the day before the meal you wish to attend. Skim milk and desserts with no sugar added are available in many locations. Ask the site supervisor for more information. Peace Meal sometimes needs to substitute on menus, but still guarantees a nutritious meal.

The Peace Meal Senior Nutrition Program suggests a donation of \$3.50 for each congregate and home delivered meal, however, no older person will be denied a meal because of their inability to contribute to the cost of the meal.
