LAKE WORTH VILLA ONLY HOTEL IN ADDITION NUMBER ONE



In Addition No. I, on the beautiful three mile drive section of the Dixie Highway, and within 100 feet of the lake is located the latest addition to the hostelries of Lake 'Worth. It is very appropriately named "Lake Worth Villa" by G. W. Fairchild, the owner and manager.

Mr. Fairchild has had a wide experience in the hotel business, having been for several years connected with hotels in the famous Adirondack Mountains in northern New York. In the building of this hotel, the owner forgot nothing that would add comfort to the visit of the winter tourist.

The hotel is built after the Queen Anne style and cost in the neighborhood of \$8,000. There are 16 rooms with all the latest appointments found in the most modern hotels. The rooms are so laid out that it is possible for a family to occupy a suite of rooms and still have the intimate privacy that is enjoyed at home. Private baths, running hot and cold water and electric lights add much to the convenience of the guest. A beautiful view is obtained from every room of the lake and Hypoluxo Island.

On two sides of the building is a promenade 100 feet in length where the guests hold receptions, dances, card parties and other social affairs.

The main hall is furnished in mission style with a big open fireplace, and a wide stairway leads to the second floor. Off the main hall is the dining room of sufficient size to permit the holding of large parties and socials.

Mr. Fairchild maintains an auto service for the comfort and convenience of his guests, and then, too, there are rowboats at the disposal of those who desire this healthful exercise. CHRISTENED SITE OF NEW GROVE AND HOME 'KNOB HILL'

Few persons are aware of the many changes which have taken place within the last few weeks in the property along the eastern shore of Lake Osborn, and known as Means' Island.

A 12 acre tract has been cleared and made ready for planting a grove of 400 citrus and 200 avocado trees, which will be of the Trapp and Pollock variety. The trees will be "set out in February, but meanwhile a small tract will be cultivated and planted for trucking.

Especially fine citrus and avocado land is found along this ridge, which has a considerable elevation and from which may be had a beautiful view of the north and south arms of Lake Osborn. The elevated portion of the tract has been christened "Knob Hill" and will later be the site of a residence which Mr. Means is now planning to erect for his home.

The soil on the side of the ridge is of a sandy nature, while that at the base is clear muck teeming with fertility. It is on this low muck that Mr. Means will plant such vegetables as beans, peppers, tomatoes, lettuce and eggplant. An experiment with lettuce has shown that plants have grown three times their size at planting within a period of 10 days. A small portion of the tract has been covered with sawgrass. Here will be planted a crop of velvet beans, which will be allowed to mature and then plowed under.

BRIDGE OVER LAKE TO BE 1400 FEFT LONG 16 FEET WIDE

This week the county commission ers are advertising for bids on a wood- en bridge which is to be constructed across Lake Osborn at a point at about two miles south of Lake Worth. The petition for the bridge was presented by Lantana residents at a recent meeting of

the county commissioners and accepted.

The bridge will be 1,400 feet in length and 16 feet in width and will be constructed on the section line between townships 44 and 45. This will give access to an immense territory which at present is only sparsely populated. The estimated cost of the bridge is 15,000, but until bids are opened the actual amount cannot be determined.

The cost of the bridge will come out of this district's share of the road funds received from the sale of bonds.

Other towns in the district to have roads and bridges constructed with money from this issue are Boynton, Hypoluxo and Lake Worth.

At the same meeting of the commissioners Orrin Randolph, Alex Drake and Charles Gardner were appointed viewers of the road west of Lake Worth as a result of a petition received to rock this road.

level of your home, and inside and outside bedrooms and sleeping areas. Change the batteries at least once a year, if your model requires it. Also, check the manufacturer's date of your smoke alarms. If they're 10 years or older, they need to be replaced because the sensor becomes less sensitive over time. Follow the manufacturer's instructions.

Practice your escape plan until everyone can get out in less than two minutes. To create your home fire escape plan, include at least two ways to exit every room in your home. Select a meeting spot at a safe

distance away from your home, such as your neighbor's home or landmark like a specific tree in your front yard, where everyone knows to meet. Teach children what a smoke alarm sounds like. Talk about fire safety and what to do in an emergency.


ORDINANCE NO. O-14-2021

AN ORDINANCE OF THE TOWN COUNCIL OF THE TOWN OF LANTANA, FLORIDA, AMENDING CHAPTER 23 - ZONING, BY AMENDING SECTION 23-1. DEFINITION OF TERMS. BY DELETING HOME OCCUPATIONS AND ADDING HOME-BASED BUSINESSES; AMENDING SECTION 23-92. R1A RESIDENTIAL DISTRICT TO IDENTIFY HOME-BASED BUSINESSES AS A PERMITTED USE; AMENDING SECTION 23-93. R1 RESIDENTIAL DISTRICT TO IDENTIFY HOME-BASED BUSINESSES AS A PERMITTED USE; AMENDING SECTION 23-94. R3 RESIDENTIAL DISTRICT TO IDENTIFY HOME-BASED BUSINESSES AS A PERMITTED USE; AMENDING SECTION 23-95. R15 RESIDENTIAL DISTRICT TO IDENTIFY HOME-BASED BUSINESSES AS A PERMITTED USE; AMENDING SECTION 23-99. MHP MOBILE HOME PARK DISTRICT TO IDENTIFY HOME-BASED BUSINESSES AS A PERMITTED USE; AMENDING SECTION 23-101. MXD MIXED USE DEVELOPMENT DISTRICT TO IDENTIFY HOME-BASED BUSINESSES AS A PERMITTED USE; AMENDING SECTION 23-102. MI MIXED USE INDUSTRIAL DISTRICT TO IDENTIFY HOME-BASED BUSINESSES AS A PERMITTED USE; AMENDING SECTION 23-102. MI MIXED USE INDUSTRIAL DISTRICT TO IDENTIFY HOME-BASED BUSINESSES AS A PERMITTED USE; AND AMENDING SECTION 23-103. MW WATERFRONT MIXED USE DISTRICT TO IDENTIFY HOME-BASED BUSINESSES AS A PERMITTED USE; AND AMENDING SECTION 23-103. MW WATERFRONT MIXED USE DISTRICT TO IDENTIFY HOME-BASED BUSINESSES AS A PERMITTED USE; PROVIDING THAT REMAINDER OF CHAPTER 23 – ZONING SHALL REMAIN IN FULL FORCE AND EFFECT AS PREVIOUSLY ENACTED; PROVIDING A CONFLICTS CLAUSE, A SEVERABILITY CLAUSE, AND AUTHORITY TO CODIFY; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

The Town Council of the Town of Lantana will hold a Public Hearing on **Monday**, **January 24 2022, at 6:00 p.m.** at Town Hall of the Town of Lantana, Florida, 500 Greynolds Circle, Lantana, Florida, or as soon thereafter as possible which may be continued from time to time and place to place as necessary in order to consider

All interested parties are invited to appear at the meeting as may be continued from time to time and to be heard with respect to the proposed ordinance. A copy of Ordinance O-14-2021 can be inspected and copied at the office of the Town Hall during normal business hours of 8:30 a.m. to 4:30 p.m. Monday through Friday. All interested persons are encouraged to come to the public hearing and be heard.

If a person decides to appeal any decision of the Town Council with respect to any matter considered at such meeting or hearing, he or she will need a record of the proceedings, and that, for such purpose, he or she may need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based.
