Deadline to File for Office is Extended

Those seeking political office now have until January 25 to declare their candidacy.

Last week, the Kentucky General Assembly passed a bill extending the filing deadline to later this month.

Kentucky Governor Andy Beshear signed the bill within hours of its passage.

The new deadline will reportedly address current congressional and legislative redistricting plans under consideration in Frankfort.

The redistricting process could take several weeks, officials said.

Present office holders may find themselves in new or different districts, and the interest of potential candidates may be affected by redistricting.

Prior to the original, January 7 deadline, nearly 50 people declared their candidacy for the upcoming Primary Election.

The Russell County Judge Executive's race has seen the most interest with seven candidates filing for that office as of presstime.

Four people are seeking the office of Russell Court Clerk.

At the December meeting of the Russell County Fiscal Court, current Clerk Sue Popplewell Brockman said she did not intend to seek office again, and was commended by the court for her service.

Jamestown City Councilman Barry Coffey recently filed papers to lead the city after Mayor Nick Shearer announced his resignation to accept a leadership position with the Lake Cumberland Community Action Agency.

Hinton Sworn In As Jamestown Mayor

Surrounded by friends, family, and well-wishers, Regena Murray Hinton was sworn into office last week as Mayor of Jamestown.

Hinton, who had been serving as a council member, was chosen to replace exiting Mayor Nick Shearer - who recently accepted a leadership role with the Lake Cumberland Community Action Agency (LCCAA).

Last Monday, at a special called meeting of the

Jamestown City Council, City Attorney H.K. Cooper administered the oath of office to Hinton.

Cooper explained the city had accepted Shearer's resignation, and "some member of this body" (Aside from Hinton), would have to serve "as moderator, mayor pro-tem, or whatever...for the purposes of swearing her in."
