Pastor Tony Stephens, of Cross Creek, recently received a check from the Lake Area Foundation (LAF).

The foundation is a tax-exempt, nonprofit, autonomous, publicly supported, philanthropic institution with a long term goal of building permanent, named, component funds established by many separate donors to carry out and support charitable interests for the benefit of residents of a defined geographic area.

The Lake Area Foundation’s identified service area consists of

Adair, Casey, Clinton, Cumberland, Green, McCreary, Pulaski, Russell, Taylor and Wayne Counties in Kentucky - with the flexibility to expand its service area to other parts of south-central Kentucky as nearby communities express interest in utilizing the Foundation’s administrative capabilities; and create funds to serve additional counties.

Created as a vehicle to administer endowed funds which will continue charitable support on behalf of the donor for generations to come, the Lake Area Foundation Board of Directors recognizes people were created with the inherent desire to make a difference and to leave a legacy.

The Foundation exists because, “What we do for ourselves dies with us; what we do for others and the world remains and is immortal.”

The Cross Creek Building and Maintenance Fund was started on June 15, 2018.

This fund was started to help with the maintenance and building of Cross Creek Church.

Donations and contributions have been made by church members.

When a balance of \$10,000 is reached, an annual distribution from the earnings can be disbursed.

This is the first year that Cross Creek received a distribution.
