Gosser Continues Hot Streak As Lakers Roll On The Road

The Lakers and Lady Lakers were in action last Monday night on the road at Cumberland County for a boy/girl double header.

In the first game of the evening, the Lady Lakers defeated Cumberland County by a score of 51-39.

Russell County shot 36 percent from the field, 14 percent from the three point range, and 77 percent from the free throw line.

The Lady Lakers

out-rebounded the Panthers 35 to 27.

Maleah Preston led the Lady Lakers in scoring with 17 points and 10 rebounds.

Sophie Shearer followed with 13 points and 13 rebounds, Jaterria Coffey had seven, Aniyah Coffey had six, Hannah Yates had five, Karley Luttrell contributed two, and Addison Hart, one.

The Laker Boys were defeated by the Panthers by a score of 75-51.

Russell County shot

34 percent from the field, 28 percent from the three point line, and 70 percent from the free throw line.

Owen Loy and Mayes Gosser led the Lakers in scoring with 19 points each.

Trace Stringer added eight, Braydon Cerrato, four, and Jack Shearer, one.

Thursday night, the Lakers and Lady Lakers traveled to Tompkinsville for another boy/girl double header against Monroe County.

(Monroe County will join the 16th district in the 2022/2023 season.)

The Lady Lakers were defeated by the Lady Falcons by a score of 58-30.

Karley Luttrell led the Lakers in scoring with nine points - followed by Maleah Preston with eight, Addison Hart with six, Camdin Cooper had five, and Sophie Shearer added in two for the night.

The Lakers shot 29 percent from the field, 16.7 percent from the three-point line, and

57 percent at the free throw line.

The Laker Boys were defeated, as well, by a score of 73-64.

Mayes Gosser held on to his hot streak by scoring with 23 points and snagging eight rebounds.

Gosser also shot 71 percent from the field and 66 percent from the three point line.

He was followed in scoring by Trace Stringer with 16 points, Owen Loy, 14, Braydon Cerrato, seven, and Maxon Gosser tossed

in four.

The Lakers Boys versed Clinton County on Sunday in a game that had to be re-scheduled twice due to weather.

Russell County fell by a score of 57-46.

The Lady Lakers were not able to play Clinton County due to COVID.

The Lakers Boys are 3-15 on the season, while the Lady Lakers are 8-12.

February is the Month of Love

More has been written about love than any other subject ever. The words to most pop songs are about love, endless poetry is written about love, there are plays and films and books which try to explain what it is, what it does to you and finally – how hard it is to define!

Definitions of Love include: The first is Eros - a physical or sexual love in a relationship. The word eros was commonly used in the Greek-speaking world of New Testament times. The second definition is Philo meaning a warm affection in families and friendships. The third definition of love is Agapē - the sacrificial, unconditional love of God for humanity.

But it is to religion that I turn to for the best definition that I know. It is not just about romantic love, but real, all-encompassing love and in reading and understanding these words of Paul in his letter to the Corinthians' 2000 years ago that we can begin to understand the mystery and majesty of this thing called love found in Corinthians 13, also known as the Love Chapter:

If I speak in the

tongues of men and of angels, but have not love, I am only a resounding gong or a clanging cymbal. If I have the gift of prophecy and can fathom all mysteries and all knowledge, and if I have a faith that can move mountains, but have not love, I am nothing. If I give all I possess to the poor and surrender my body to the flames, but have not love, I gain nothing. Love is patient, love is kind. It does not envy, it does not boast, it is not proud. It is not rude, it is not self-seeking, it is not easily angered, it keeps no record of wrongs. Love does not delight in evil but rejoices with the truth. It always protects, always trusts, always hopes, always perseveres. Love never fails. But where there are prophecies, they will cease; where there are tongues, they will be stilled; where there is knowledge, it will pass away. For we know in part and we prophesy in part, but when perfection comes, the imperfect disappears. When I was a child, I talked like a child, I thought like a child, I reasoned like a child. When I became a man, I put childish ways behind me. Now we see but a poor reflection as in a mirror; then we shall

see face to face. Now I know in part; then I shall know fully, even as I am fully known. And now these three remain: faith, hope and love. But the greatest of these is love.

You don't need to be Christian to understand and appreciate these words and how they apply to everything we do at home, at work and yes, in our personal lives. Some of them are especially important for couples: love is not self-seeking, look out for your partner's interests as well as your own; love is not easily angered, breathe deeply (and think twice) before answering; love keeps no record of wrongs, forgive and forget – and never bring it up again. This is the NUMBER ONE cause of break ups: the wounds that are continually brought up because we won't let them go.

Think on these things during the month of LOVE. But if you are really in love – it's true, believe it – True Love Never Fails. Love God and All People. Amen.

ORDINANCE NUMBER 2021-006

AN ORDINANCE TO THE CITY OF JAMESTOWN, KENTUCKY, ADOPTING WITH AMENDMENTS FOUND HEREIN, THE FOLLOWING SET OF REGULATIONS AND REQUIREMENTS FOR ALCOHOL BEVERAGE CONTROL, HEREIN AFTER TO BE KNOWN AS THE CITY OF JAMESTOWN "ALCOHOLIC BEVERAGE CONTROL ORDINANCE"; AND FURTHER ADOPTING ALL APPLICABLE AND REQUIRED KRS, INCLUDING BUT NOT LIMITED TO, KRS CHAPTERS 241 THROUGH 244 AS RECENTLY UPDATED BY THE GENERAL ASSEMBLY AND ADMINISTRATIVE AGENCIES; AND

WHEREAS, THE CITY OF JAMESTOWN, BY AND THROUGH A MAJORITY OF REGISTERED VOTERS, PERMITS THE PRESENCE OF ALCOHOL, MANUFACTURING OF ALCOHOL, AND SALES OF ALCOHOL WITHIN THE CORPORATE LIMITS OF THE CITY OF JAMESTOWN SO LONG AS SUCH IS DONE IN ACCORDANCE WITH ALL APPLICABLE LOCAL, STATE, AND FEDERAL LAW; AND

WHEREAS, THE CITY OF JAMESTOWN THEREFORE HAS ESTABLISHED UNIFORM REGULATIONS AND REQUIREMENTS FOR THE LICENSING AND REGULATION OF ALCOHOLIC BEVERAGES, MANUFACTURING, AND SALES PURSUANT TO AUTHORIZATION UNDER KRS CHAPTERS 241 THROUGH 244, AND ALL OTHER APPLICABLE LAW;

NOW THEREFORE, BE IT ORDAINED BY THE CITY OF JAMESTOWN, KENTUCKY, THAT THE FOLLOWING REGULATIONS AND REQUIREMENTS ARE HEREBY ADOPTED AS SET FORTH BELOW:
