#### **Plan Underway To Relocate 911 Center**

#### **Staff Report**

Discussion is underway to move the Russell County 911 Center to a new location.

Last Monday, at the regular monthly meeting of the Russell County Fiscal Court, Judge Executive Gary D. Robertson read a letter from the City of Russell Springs regarding a "proposed, new 911 facility.'

The letter, dated January 27 and signed by Russell Springs Mayor Eddie Thomas, offered one acre of land on Brian Walters Drive "for the sum of \$1 for the purpose of the future construction site for the 911 Center."

"We would like to offer

free natural gas, water and sewer hookup for this facility," the mayor said.

"I know at one time we talked about possibly buying the old library (Now home to ArtWorks on Main)...but we didn't think that was feasible," Judge Robertson said.

The judge said he "checked with other counties" who are using American Rescue Plan Act (ARPA) money for "governmental benefits...and that (Construction of a new 911 Center) would qualify."

The Russell County 911 Center has been housed in

#### **Staff report**

An enthusiastic Gov. Andy Beshear brought over \$700,000 to Russell County last week for water and road projects.

"I hope you see this as a good day," Beshear told a large crowd gathered at the Lake Cumberland Area Development District in Russell Springs Friday.

The governor delivered nearly \$6 million to Russell, Cumberland, Clinton, Wayne, Metcalfe, Barren, Monroe, Allen and Hart Counties to provide cleaner drinking water and improved sewer and wastewater systems.

The funding, part of the Better Kentucky Plan's \$250 million Cleaner Water Program, is expected to create an estimated 3,800 jobs across the state.

"I'm excited about the Better Kentucky Plan," Beshear said. "Working

together, we are building a better Kentucky with improved, resilient infrastructure that supports our residents and meets the needs of our growing economy."

"Every Kentuckian has the right to expect access to clean drinking water," the governor said.

At Friday's local event, Beshear handed out what he called "the big checks"

to officials from Russell, Clinton, Cumberland, and Wayne Counties.

The Cities of Jamestown and Russell Springs each received over \$329,000 for
