International Student Services (ISS): Graduate Immigration Specialist is responsible for all international student processes including but not limited to issuing I-20's, maintaining compliance with all government organizations monitoring international student visa regulations by serving as a Designated School Official. Maintain advanced knowledge of SEVP, F-1/F-2, visas for students including Student and Visitor, and DHS.

This position supports the ISS staff including but not limited to the Director and Associate Director of International Student Services. This position is part of the training and support team for satellite campus locations.
