When Columbia University researcher, Kelli Harding began her clinical practice, she never intended to explore the invisible factors behind our health. But then there were those rabbits. The exciting news is that every day we have the opportunity to increase kindness and connection in all areas of our lives. Be intentional about thanking people who help you including anyone who helps you in restaurants and stores. Recognize their hard work and

thank them. Above All, Be Kind.

This week, Set the intention to Be Kind in all your interactions with everyone. And so, remember, Matthew 7:12 ESV "Love is patient and kind; love does not envy or boast; it is not arrogant or rude. It does not insist on its own way; it is not irritable or resentful; it does not rejoice at wrongdoing but rejoices with the truth. Love bears all things, believes all things, hopes all things, endures all things.
