Douglas County Board calls special meeting

Douglas County Board Chair Don Munson called a special board meeting to order at 9:00 a.m. The first item for consideration was a backup system for the dispatch system for the county. In June of 2014, a storm that caused a great deal of damage in Tuscola also compromised the existing system and since that time Edgar County has been the backup for Douglas County. Although there have been no problems with calls rolling over to Edgar County, a system for the county is considered to be necessary to maintain the best service. Depending on Edgar County could be problematic if emergencies in that county were to overburden their personnel.

The EMA subcommittee had requested that Deena Kidwell solicit pricing for a new system for Douglas County and she presented a bid to the full board at this meeting.

The board voted 7-0 to accept a contract with Barbeck Communications for a consolette to be placed in the Annex to be connected to the Sheriff's department for \$36,271.79. A new system to include three stardom channels will also be installed for a cost of \$76,057.00 for a total of \$111,328,79 to be paid from the general services budget. None of the bids

The second item on the Agenda dealt with ARPA (American Recovery Plan Act) funds.

To date, \$1,000,000.00 has been approved for a joint agency water line to service the western part of the county. The existing line is not adequate for the growth that has taken place in the area. Newman will receive \$450,000.00 for upgrades to the water tower and water plant. Recipients of both awards are contributing their own funds to the projects as well.

Chair Munson has contacted the municipalities and other entities so they could petition for some of the ARPA funds and the Board discussed these requests and have put them under consideration. No project has been funded at this time, however, the list of requests for use of "lost revenue funds" under APRA was presented at this meeting.

A request of \$80,000.00 was made for refurbishing the County dog pound.

A storage building and garage for the Annex was requested for an estimate of \$50,000.00. Board member Gary Luth suggested that this request could be part of a proposed building for the Highway Department which would replace the existing structure. The current building has been evaluated and the conclusion is that it would cost less to build a new structure than bringing the present structure up to standards.

The building for the garage, IT, and administration for the County Highway Department is under consideration for ARPA funds. However there is no estimate available for the improvements at this time. Therefore, this is the time to consider combining the requests.

There is consideration for two vehicles to be used by the Coroner's office. The amount requested is \$80,000.00 One vehicle has been ordered and will be delivered this summer. A second vehicle has been requested to supplement the office. After discussion, the board suggested raising the amount for the coroner vehicles to \$120,000.00.

A request for a new EMS truck was made as the current truck is unreliable. Currently a 26-year-old on- ton Dodge truck is used to transport the EMMA trailer and a four wheel "Mule" that is used in search situations. This truck is unreliable especially as it sits for extended periods of time. A suggestion was made to consider contacting a number of Douglas County residents who have ton trucks that might consider renting them on an as needed basis. The request for a "new" ton truck was raised from \$30,000.00 to \$50,000.

The City of Arthur has requested \$288,000.00 for improvements to its water tower. Arthur will be contributing another \$288,000.00 if this request is approved. Although part of the City of Arthur is in Moultrie County, no funds from that county will likely be forthcoming.

The RISE Crisis Intervention has requested \$100,000.00 so they may continue their work with those persons who are dealing with drug or alcohol problems or who may be mentally unstable. Most city agencies are minimally prepared to deal with these people and Rise "fills the gap". Rise has been able to operate up to this time because it was funded by a grant that covered the expenses of a one person organization. However, the grant was pulled when Rise could not afford three practitioners as required by the Federal government. Chair Munson stated that he would recommend \$100,000.00 be given to RISE with the understanding that it would be a one time grant to give them time to secure continuing funding.

The Douglas County Department of Health has requested help in extending water to the building on Rte 36. At this time they are using a well that has poor quality water. A line has been extended to the state building and estimates to take the line on to the Department of Health will be given to the Board.

The Arcola Food Pantry has requested \$100,000.00 for improvements to their building to include more storage and a generator to keep food from spoiling in the event of a power

The Arcola ambulance service has requested \$340,000.00 to help with defraying the expenses of a new building. Work has started on the building and will continue. However the funds, if given will help in their expenses. At this time discussion took placer regarding the current service contracts that Villa Grove and Tuscola have with Carle Ambulance. Although both cities have contracts with Carle (and other municipalities contribute to these contracts), Carle reserves the right to keep ambulances in Champaign after they have delivered patients to the hospital. Therefore, the county can be without service. It was suggested that cooperation between the various county townships and municipalities might enable the county to form their own cooperative.

It must be noted that no action was taken on any of these requests. The meeting was to present the various requests to the board. Any action on these requests will be taken at a later date after due consideration.
