Topping: 2 lb. sausage, fried 1 c. spaghetti, cooked amd

drained 1 pt. pizza sauce 1 c. sour cream 3 Tbsp. salad dressing 3 c. shredded cheese Mix crust ingredients and pat in bottom of a 9'x13' pan. Put meat on top of dough, and spaghetti on top of meat. Spread pizza sauce over spaghetti. Mix sour cream and salad dressing and put on top of pizza sauce; cover with grated cheese and (pepperoni, optional). Bake at 350 degrees until crust is brown. Mexican Lasagna 1 lb. hamburger 16 oz. can refried beans 2 tsp. oregano 1 tsp. ground cumin

³/₄ tsp. garlic powder

12 uncooked lasagna noodles

2½ c. water 2½ c. salsa 2 c sour cream ³⁄₄ c. chopped onions 2 oz. sliced black olives 1 c. shredded Monterey Jack cheese

Combine fried hamburger, beans, and spices. Place 4 of the uncooked noodles in the bottom of a 9'x13' pan. Spread half the meat mixture over noodles. Top with 4 more noodles and remaining meat mixture. Cover with remaining noodles. Combine water with salsa. Pour over all; cover tightly with foil; bake at 350 degrees for 11/2 hours or until noodles are tender. Combine sour cream, onions, and olives. Spoon over casserole; top with cheese. Bake uncovered until cheese melts, about 5-10 minutes.
