Chicken Pot Pie 2 tblsps. oil

1 tblsp. chopped onion 1½ tblsps. flour

34 cup chicken stock

Salt and pepper to taste 1 cup cooked chicken, cut in small pieces

¼ cup cooked peas

¼ cup cooked, diced carrot

Fry onion in oil until lightly browned. Add flour and stir until blended. Slowly add chicken stock and stir over low heat until smooth and thick. Season to taste. Arrange chicken and vegetables in layers in pie pan or 8x8 or 9x9 square cake pan, cover with sauce. Top with baking powder biscuit dough (or use Bisquick) rolled like a pastry. Bake at 425 degrees for 15-20

Can also use chicken seasoning and/or Spike veggiesalt for seasoning.
