**Treacherous Winter Storms** delay. Surprisingly, yet for-District (TFPD), like many tunately, no calls for service other public safety agencies, were received during the first 24 hours of the storm. This started planning and preparing for the recent winter storm phenomenon was attributed

As a result, department mem-

bers immediately initiated ac-

tions to ensure all apparatus,

equipment and facilities were

fully prepared for an extend-

ed period of service during

the storm. Contact was made

with district partners at the

Champaign County Emer-

gency Management Agency,

local National Weather Ser-

vice Office, Village of Tolono

Public Works, and Tolono

Township to finalize plans

for the impending storm.

TFPD maintains an excellent

working relationship with the

Village of Tolono and Tolono

Township which is very im-

portant during these events

due to the potential need for

assistance. Both the village

and township offered TFPD

plowing services should the

need arise when respond-

ing to an emergency call for

As forecasted, the storm ar-

rived early Wednesday morn-

ing and TFPD members began

plowing snow in shifts to

ensure apparatus and mem-

bers were able to respond

and stayed home instead of traveling on the treacherous roadways. On Thursday at 9:09 am, TFPD was called to respond with the Pesotum Fire Protection District for a tractor trailer fire on interstate 57. TFPD responded with two engines and a tender. Due to the dangerous road conditions and traffic congestion, access to the interstate and fire scene was a challenge. The tender which is an all-wheel drive wildland firefighting vehicle was able to use the shoulder and go through the interstate median to get to the burning truck. The tender proved to be a great asset during the period of heaviest snow fall due to its ability to travel places other apparatus could not. At 11:34, TFPD was called

to the fact that people had lis-

tened to the storm warnings

back to the interstates for a jack-knifed semi on interstate 57. The Pesotum Fire Protection District and the Village of Savoy Fire Department also responded to this incident. During this incident it was determined the interstate was no longer safe, and the interstate was closed from Monticello Road to Pesotum by the Illinois State Police. The to calls for service without interstate closure required

significant collaboration between fire agencies, state police, and IDOT. The members of the Pesotum Fire Protection District along with units from the Illinois National Guard assisted many motorists from the interstate and transported them to an emergency shelter in Pesotum. The biggest impact Tolono saw from the interstate being closed was having increased traffic on route 45, which made it even more important for people in the community to stay off the road way.

TFPD members spent the next 13 hours staffing the main station. These dedicated individuals were not required to stay but did so to ensure a quicker response to any requests for service. Having members in the station instead of responding from home was definitely beneficial. It allowed apparatus to be out the door in under two minutes. On a day when TFPD knows it is going to take longer to get places due to road conditions, having members available at the station is a tremendous advantage.

According to TFPD Chief Chris Humer, the department responded to four emergency calls for service during the height of the winter storm. Chief Humer said "I am very proud of the dedication of our members. They took time away from family, friends
