

gibbous Moon in the eastern sky. There will be two stars above and left of the Moon, making a straight line with the Moon. These are the stars Castor and Pollux, the heads of the Gemini Twins. The line is straightest at about 8pm. Keep watching as the night progresses and you'll see the Moon moving in its

Local School Districts Stance and Guidance on COVID-19 Lawsuit Temporary Restraining Order

'On Friday February 4 at 5pm, an Illinois judge granted a temporary restraining order (TRO) for the plaintiffs on lawsuits filed by some parents and school employees from throughout Illinois that challenged some state-mandated COVID-19 mitigations. For students, the challenge was the enforcement of wearing masks and quarantine exclusions from school and for employees mandating COVID vaccination proof or weekly testing.

Heritage CUSD #8 was not named as a defendant in either of these cases, and the majority of schools in the

clarification and final rulings. Circumstances may change at any time and everyone's understanding is appreciated.

Some important legal points communicated to districts today:

This is a temporary restraining order, which is by its very definition "temporary", and is not a final disposition of the issues. This ruling temporarily enjoins the actions of the parties, but it is not a permanent injunction and is not necessarily a reflection of the final merits of the case.

The state will be filing a motion for a stay on Monday that is expect to be granted. The state appeal, if successful, would likely dissolve the TRO dates targeted.

IHSA and IESA sports rules were not the subject of the litigation, and schools remain subject to those rules in order to have sanctioned contests."

Andrew Larson, Superintendent Unit 7 School District, letter to the parents of Unit 7 Schools conveying the message that Unit 7 Schools are not or have ever been named in the lawsuit. "I want to be clear when I say that the end result we are all looking for is the same; to be what we were prior to March of 2020" Larson writes. "The divisiveness regarding the mitigations that have been cast upon us along with any patience to continue with certain mitigations has run out, specifically with the mask mandate. This has caused unneeded and unwanted stress on relationships within family units, within school faculty and staff and with students." He goes on to explain that "The biggest concern currently is that an appeal has been filed from the Governor's office to stop the TRO and we may not know the answer to the appeal for several days; to act on something that could be reversed and does not include our district at this time would be reckless on my behalf and will only cause more frustration if we would need to reverse direction." "Many will not appreciate my stance on this." "Ŵhat I am asking everyone is to understand the difficult position of the Unit 7 Board of **Education and administration** at this time. Time is needed to fully understand the decisions being made outside of our district walls." " The Unit 7 School District, in working with district legal counsel and insurance carriers, will stay the course with current mitigations put in place by the Governor's Executive Order until the decision on the appeal is ruled upon."

area were also not named. Some area schools including Mahomet, Gifford, and Thomasboro were named as defendants, so they will likely be effected in the short term more directly by the TRO. The judge in this case ruled that these lawsuits do not meet the definition to qualify as a state-wide "class action."

Heritage district will continue the mitigations in place until further clarification and final rulings are posted per legal guidance below. This means wearing of masks at school and school events and on all district transportation including buses, cars, and activity vans. Visitors to school are also required to wear masks within the building(s). Contact tracing will continue for known exposures and Binax testing with parent consent will still be available.

Heritage has received legal guidance from the school attorney, Brian Braun of Miller, Tracy, Braun & Assoc. of Monticello, and PSIC, which is the district's insurance company. The guidance provided is summarized below and indicates that Heritage district will continue the mitigations in place until further and restore the named parties to their same position before the TRO.

The order only applies, by its terms, to named plaintiffs against named defendants. For those school districts who are not a party to the action, this order does not apply, and if a person asserts the order, the order does not technically apply to a non-named plaintiff or a non-named defendant.

Until a school is subject to an enforcement order, and until a plaintiff files such a challenge, a school is at least technically permitted to enforce the mandates of its own volition in coordination with its local health department. In Heritage's case, that is the Champaign-Urbana Public Health Department.

The State is seeking an emergency stay both with the Circuit Court and the 4th District Appellate Court, and the State and schools who are defendants will file to appeal the TRO on an expedited timeline, which will likely mean an order from the Appellate Court within less than two weeks with the date of February 16th/17th being communicated as the decision
