Breakfast Haystack Cas-

1 lb. bacon, fried and crum-

8 eggs, scrambled 1½ c. shredded cheddar

12 biscuits, baked 1 lb. sausage gravy

1 can mushroom soup ½ c. chopped green peppers 3 lb. shredded hash browns Preheat oven to 350 degrees. Brown potatoes and put in bottom of 9x13 pan. Layer mushroom soup, bacon, eggs, peppers, cheese, biscuits, and sausage gravy on top. Bake until thoroughly heated. De-

Ice Cream Pudding Pie 11/3 c.chocolate wafer

3 T. melted butter

1 (3.9 oz.) pkg. chocolate instant pudding mix

1 (3.4 oz.) vanilla instant pudding mix 1½ c. milk

2 tsp. instant coffee gran-

1 tsp. hot water

1 pint coffee ice cream, slightly softened

In a 9" pie plate, mix to-gether the chocolate wafer crumbs and butter until crumbly; press into the bottom and up the sides of the pie plate.

In a big mixing bowl, beat both pudding mixes with milk for 2 minutes, until thick and smooth. Dissolve the coffee granules in the hot water; add to the pudding mixture along with the ice cream and beat until well blended. Transfer this mound of bliss to the pie plate and spread evenly. Freeze several hours. Let the pie thaw about 10

minutes before cutting. If you'd like, you can drizzle each piece with marshmallow ice cream topping, sprinkle with chocolate shavings.

2 c. flour

3 tsp. baking powder 1/4 c. shortening

1 tsp. sugar

½ tsp. salt

1½ c. milk

Mix dry ingredients, then cut in shortening. Add milk. Put in 9x13 pan. Bake at 450

Spiced Bacon Twists

1 c. brown sugar

be sauteed first.

2 Tbsp. ground mustard ½ tsp. ground cinnamon ¼ tsp. cayenne pepper

1 lb bacon, medium or thick sliced

Preheat oven to 350 degrees. Line a rimmed baking sheet with foil. (This will catch fat that renders from bacon). Place with a wire rack on baking sheet. In a shallow baking dish, combine all of ingredients except bacon. Press each strip of bacon into mixture until coated on both sides. Twist each strip a few times and arrange on baking rack. Bake until bacon is browned and crisp enough to hold twisted shape, about 25-30 minutes. Cool slightly before serving.

Sausage Cheese Balls

2 lb. sausage, fried 1½ c. Bisquick mix

4 c. shredded cheddar

½ c. onions, finely chopped ½ c, celery, finely chopped ½ tsp. garlic powder

Mix together all ingredients. Form balls to size of your choice. Place on a greased pan and bake at 350 degrees for 15 minutes.

Cappuccino Muffins

2½ tsp. baking powder

375 degrees for 17-20 minutes or until finished baking. Cool 5 minutes. Remove from pan and serve with Expresso spread. Yileds: 14 muffins
