Gerald is also busy shipping 50-60 cases of school books to Indiana. Tomorrow is my busy Friday, serving lunch at the Decatur Auto Auction and delivering to the House of Meats in Decatur. I took two quilts I made to the Decatur Quilt Auction. The auction was Friday night April 8 at the Decatur Civic Center. Making the quilts is a fun hobby I enjoy doing. Saturday April 9th, I set up at the Decatur Conference Center selling biscuits and gravy for breakfast and chick-

en and noodles and lasagna dinners for lunch along with cinnamon rolls and snacks. This is a new craft show for me called the Finders Market. If you enjoy crafts be sure to check it out again June 11 and October 8 from 9 am to 3 pm. Try these dishes with friends or family for your Easter dinner.

Swedish Meatballs and Gravy
 1lb. ground beef
 1/3 c. bread crumbs
 1 egg
 1 tsp. salt
 1/2 c. milk
 2 Tbsp. chopped onion
 1/2 Tbsp. Worcestershire sauce
 1/2 tsp. black pepper
 Sauce:
 1 can cream of mushroom

soup
 1 (8 oz.) pkg. cream cheese
 1/2 c. water
 Mix meatball ingredients and shape into 2" balls. Place in a baking dish and bake at 375 degrees for 20 minutes. Meanwhile, heat sauce ingredients, then pour over meatballs and continue baking for another 30 minutes.

Salmon Loaf
 1 can pink salmon
 1 tsp. salt
 1/2 tsp. pepper
 1/4 tsp. paprika
 2 Tbsp. lemon juice
 1/2 c. cracker crumbs
 1/2 c. hot milk
 Preheat oven to 350 degrees. Mix all together and form into a loaf. Bake for 1 hour.

Ham Loaf
 1 1/4 lb. ground ham

2/3 lb. sausage
 2/3 lb. hamburger
 2 eggs
 1 c. cracker crumbs
 Salt and pepper to taste
 Sauce:
 1 c. brown sugar, packed
 1/2 c. vinegar
 2 tsp. mustard
 1/2 c. water
 Shape meat in a loaf or balls. Pour sauce over top and bake for 1 hour at 350 degrees. Use a 9x13" pan for a loaf.

Hash Brown Casserole
 1 lg. pkg. shredded hash browns
 1 med. onion
 1/4 c. butter
 1 can cream of chicken soup
 1 (12 Oz.) sour cream
 1 c. shredded cheddar cheese
 1 tsp. salt

Put potatoes in 1 1/2 to 2-quart oven-proof casserole dish with 1 tablespoon oil. Mix ingredients and pour over potatoes. Bake 30 minutes at 375 degrees. Remove from oven and sprinkle top with 1 cup crushed cornflakes. Dot with butter and bake an additional 15 minutes.

Gourmet Potatoes
 10 lb. potatoes, cooked & mashed
 1 1/2 lb. sour cream
 1 Tbsp. minced onion
 3/4 c. butter
 2 cans evaporated milk
 Salt to taste
 3 c. cheddar cheese
 Mix (beat) all ingredients together. If it's too stiff, add milk. Brown butter and put on top when done. This can be made ahead of time.

Serves 20 to 25 people.

Scalloped Cheesy Potatoes
 1-10 1/4 oz. can condensed cream of mushroom soup
 8 oz. shredded cheddar cheese
 2 lb. potatoes (peeled & sliced)
 1 medium onion, chopped
 3/4 c. crushed Ritz crackers (about 18)
 In a large bowl, stir together soup and cheese. With a rubber spatula, fold in onion and potatoes until thoroughly coated. Scrape into a greased 9"x13"x2" baking dish. Cover with tinfoil. Bake for 1 hour or until potatoes are tender. Sprinkle top with cracker crumbs. Bake until top is golden brown (about 5-10 minutes). Let set for 10 minutes before serving.

Village of Sidney Board of Trustees 2022 - 2023 fiscal year (May 2022 - April 2023) meeting dates were approved under President Arrasmith's comments following a motion from Trustee Dan Gadeken and a second by Trustee Matt Laurent.

Trustee Bret Harris made a motion that was seconded by Trustee Matt Laurent to approve the consulting contract with SIMEC Energy following discussion and confirmation that there was no charge to the village.

The \$3,132.93 Champaign County Animal Control contract was discussed under President Arrasmith's comments. A motion from Trustee Brett Harris seconded by

Trustee Dan Gadeken to approve the contract carried.

Village of Sidney Attorney Marc Miller informed the board that they had been asked to participate in a City of Champaign challenge of the Illinois American Water rate hike and that it would cost the Village of Sidney \$230.00 to join in for a lawyer to challenge the rate hike. Trustees decided to have Village of Sidney Attorney Marc Miller write up paperwork and add the board reviewing and discussing it to their Monday, May 2 meeting agenda.

Village of Sidney Maintenance Supervisor Jeff Wyant reported on drainage problems that he had been working on particularly east of Byron Street to the creek and the west end of Byron Street where drainage needed to be cleaned out and jetted due to drains and drain lines being clogged and how it is an on-

going problem that needs to be worked on.

Mr. Wyant also reported that Duce Construction had poured the sidewalk downtown along David Street, that they would return to take out the forms, and that he had replaced bulbs in the scoreboard, had put the batting cage net up, and had ordered a new and replaced the old American Flag at the Witt Park Ball Park.

Village of Sidney Board Trustee and Finance Chair Donna Hooker gave the finance report. A motion from Trustee Hooker seconded by Trustee Dan Gadeken to pay all of the monthly bills for March including eight additional bills brought to the meeting carried.

Village of Sidney Board Trustee and Streets and Alleys

Chair Dan Gadeken reported that the IDOT would be replacing the village's damaged radar sign on the east side of town, that tarring and chipping of roads would soon be done in the village, and that building permit #743 had been issued to the property owner of 31 Dunlap Woods to erect a sunroom.

Village of Sidney Board Trustee and Water and Drainage Chair Bret Harris reported that he had met with the Dunlap Woods Homeowners Association and that they stated that they would fix the drain problem if the Village of Sidney could prove that it was not the village's drain, but was in fact owned by the Dunlap Woods Subdivision. Trustee Harris and Village of Sidney Maintenance Supervisor Jeff Wyant will continue to

work on the problem.

Trustee Harris also reported that Byron Street east to the west to the alley had a real problem with leaves needing to be sucked out of man holes messing with drainage. Village of Sidney Maintenance Supervisor Jeff Wyant will put together a list of drains/man holes needing to be cleaned out.

There was no public property report as Village of Sidney Board Trustee and Public Property Chair Tyler Bickers was absent from the meeting.

Village of Sidney Board Trustee and Parks and Recreation Chair Matt Laurent reported that folks were putting garbage in Witt Park dumpsters and that the Village of Sidney will be checking video from the already installed cameras located at the park.

There was no community development report as Village of Sidney Board Trustee and Community Development Chair Leroy Schluter was absent from the meeting.

The Village of Sidney Board of Trustees meeting was brought to adjournment at 7:48 p.m. following a motion from Trustee Dan Gadeken and a second by Trustee Matt Laurent.

feel flu-like symptoms, self-isolate and stay home from work; and obtain a test as quickly as possible.

- If you test positive, talk to your provider immediately so you can get COVID-19 treatment within 5 days of starting to feel sick. Also, communicate about the positive result with any persons you have been in close contact within two days of falling sick or testing positive.
- Continue to frequently wash your hands and cover coughs and sneezes.

In addition, on March 29, the Centers for Disease Control and Prevention (CDC) issued updated guidance that authorized a second booster dose for certain segments of the population at least four months after the first booster dose. This applies to adults over 50 years of age, and to immunocompromised individuals over 12 years old. The CDC also recommended a second booster dose with an mRNA vaccine for all those who received the Johnson & Johnson vaccine for both their primary dose and their first booster,

Johnson and Johnson primary vaccine do not need an additional booster unless they are either over the age of 50 years or immunocompromised.

The State of Illinois remains strongly positioned to respond in the event of a new COVID-19 surge. The State stockpile of tests is nearly
