Illinois Corn Marketing Board **Referendum Passes**

Illinois corn producers overwhelmingly approved an increase in the check-off rate they pay when marketing their grain. By a vote of 1078 to 141, they passed a referendum March 29 to raise the rate by 1/4 cent per bushel. The referendum result was announced today after the Illinois Department of Agriculture (IDOA) completed its review of the ballots and certified the state-

The Illinois Corn Marketing Board (ICMB) requested the referendum by petitioning the Director of Agriculture. The measure was supported on 88 percent of the ballots cast. That means effective Oct. 1, 2022, the current 5/8 cent check-off rate will increase to 7/8 of a cent per bushel. If they choose, however, corn farmers still have the right to receive a

The ICMB, a volunteer board of corn farmers elected by their peers, administers the check-off fund. Members invest the proceeds in market development, research, education and promotion programs designed to enhance the profitability of Illinois corn

Feeders & Baths until May 31 The Illinois Department of especially those that water-

Natural Resources (IDNR) today issued updated public recommendations regarding wild birds and the EA H5N1 strain of Highly Pathogenic Avian Influenza (HPAI) currently impacting some wild and domestic bird species.

While HPAI has not been detected in songbird species (passerines), IDNR recommends the use of bird feeders and bird baths cease through May 31, or until HPAI infections in the Midwest subside, fowl may visit. During spring, wild birds will have ample food sources while bird feeders are removed.

Further IDNR recommendations:

 Clean and rinse bird feeders and baths with a diluted bleach solution (nine parts water to one part bleach) and put away or clean weekly if they can't be moved away

• Remove any bird seed at the base of bird feeders to discourage large gatherings of birds or other wildlife.

• Avoid feeding wild birds in close proximity to domestic

If five or more deceased wild birds are observed in one location, an IDNR district wildlife biologist should be contacted. Contact information for district wildlife biologists can be found at https://www.wildlifeillinois. org. USDA Wildlife Services also may be contacted at 1-866-487-3297.

My spring is filling up fast. Try these rhubarb recipes. Rhubarb Cream Delight

1½ c. flour ¾ c. butter

3 Tbsp. sugar

Combine crust ingredients until crumbly. Press into 9x13 pan. Bake at 350 degrees for 20 minutes

Cream Filling: 1 c. sugar

4 c. rhubarb

4 egg yolks, beaten

½ tsp. nutmeg 2 Tbsp. cornstarch

2/3 c. evaporated milk

Combine filling ingredients and boil till mixture thickens. Pour over crust. Top with meringe. Put in oven till golden Meringue:

4 egg whites ¼ tsp. cornstarch ½ c. sugar

¼ tsp. cream of tartar

1 tsp. vanilla

Beat egg whites till foamy. Beat in cornstarch and cream of tartar till peaks form. Gradually bet in sugar and vanilla till stiff but not dry.

Rhubarb Tapioca

8 c. water

1 tsp. salt 1 c. Minute tapioca

11/3 c. strawberry Jell-O

Bring water to boil. Add tapioca and salt; bring to boil again for a few minutes. Keep stirring, then add Jell-O. Set aside and cover.

8 c. rhubarb, cut up,

1 tsp. salt 5 c. sugar

2 c. water

and water till rhubarb is soft. Add to tapioca mixture. Add whipped topping before serving. Makes 5 quarts.

½ c. butter Mix cake mix and butter together until crumbly. Sprinkle over rhubarb layer. Pour 1 cup water over whole mixture. Do not stir. Bake at 350

degrees for one hour. Serve

with milk or whipped cream. Rhubarb Bars

Crust:

1 c. flour

5 Tbsp. powdered sugar

½ c. butter, or margarine

Mix flour, powdered sugar, Boil rhubarb, salt, sugar, and butter with a fork. Pat 15 minutes at 350 degrees. Top Layer:

2 eggs

1 c. sugar ½ tsp. salt

¼ c. plus 1 Tbsp. flour 2 c. chopped rhubarb

Beat eggs; add sugar, salt, and flour. Stir in rhubarb and spoon over baked crust. Bake at 350 degrees for 35-45 minutes until done.

Rhubarb Crumb Pie

1 c. sugar

2 Tbsp. melted butter

2Tbsp. flour

6 Tbsp. water 4 c. rĥubarb

Mix and pour into unbaked pie shell.

Crumbs:

1 c. flour

½ c. brown sugar

½ c. butter ½ c. walnuts (optional) then turn down to 350 degrees and bake 30-40 minutes

Mix until crumbs form.

Add to top of rhubarb. Bake

at 400 degrees for 10 minutes

Rhubarb Custard Pie 1 c. finely-cut rhubarb, heaping

Place rhubarb in unbaked pie shell 34 c. sugar

1 tbsp. flour Pinch salt

1 c. milk

2 egg yolks

1 Tbsp. melted butter Mix sugar, flour, and salt.

Add milk, eggyolks, and melted butter. Pour over rhubarb. Bake until firm.
