The six-story building will also house the LeMieux Center for Public Policy, which continues to bring a grounded perspective to important issues for students and the local community.

The God-Sized Dreams campaign coincides with historic growth at PBA,

which just welcomed a record-breaking incoming class at a time when many institutions face declining enrollment. PBA's location in downtown West Palm Beach enables students to intern and work with esteemed businesses in tech, energy, finance, and health care, as demand grows for well-rounded young professionals who exemplify integrity, faith, and a commitment to service. Around 91 percent of PBA graduates enroll in graduate school or hold a full-time job within six months of graduation.

Encourage S/M/WBEs to participate in the SWA's purchasing process;

Promote the business development of S/M/WBEs through education and outreach to Prime Contractors, Subcontractors, Suppliers, certified S/M/WBEs and SWA staff;

Encourage firms to get Certified as a S/M/WBE and take advantage of Affirmative Procurement Initiatives (narrowly tailored S/M/WBE goals) in Solicitations that may increase their access to contract opportunities; and

Ensure that Prime Contractors fulfill their S/M/WBE subcontract commitments by contract monitoring and tracking.

No waste collection in unincorporated Palm Beach County on Thanksgiving Day



Garbage, recyclables, yard waste and bulk waste will NOT be collected on Thanksgiving Day, Thursday, Nov. 24, for residents living in unincorporated Palm Beach County. Solid Waste Authority of Palm Beach County (SWA) transfer stations, Home Chemical & Recycling Centers, landfill and administrative offices will be closed. In addition, Customer Service team members will not be on duty.

There will be no makeup collection day for garbage, recycling, yard waste or bulk waste. Waste collection for unincorporated residents impacted by the holiday will resume on their next regularly scheduled service day:

Garbage collection: Monday, Nov. 27

Recycling, yard waste and bulk waste collection: Thursday, Nov. 30

With the increase of garbage around the Thanksgiving and Christmas holidays, there are special holiday provisions in the collections contract for residents living in unincorporated Palm Beach County, as follows:

Garbage

Per the collections contract, on the Friday, Saturday and Monday following Thanksgiving, and from Dec. 26 through Jan. 1, excess garbage can be placed outside of the stan-

dardized SWA garbage cart at the curb for pick up

Excess garbage placed outside of the standard-ized SWA garbage cart must be properly secured in plastic bags weighing less than 50 pounds when filled

All waste should be placed curbside by 6 a.m.

Recycling

Oversized or excess carboard may always be placed beside the yellow recycling bin for collection

All non-cardboard packing material must be removed

Yard waste

Remains limited to six cubic yards on the next yard waste collection day

Bulk waste

Remains limited to three items at the curb on the next bulk waste collection day

administrative **SWA** offices will also be closed the Friday (Nov. 24) after Thanksgiving. However, the transfer stations, Home Chemical & Recycling Centers, and landfill will be open and waste collection will occur as scheduled. There will also be a limited number of Customer Service team members available to assist residents with their questions or concerns. Residents in unincorporated Palm Beach County can see their updated collection schedule, set reminders and sign up for collection information through the "My Pick-Up Days" tool on the SWA website.

Residents who live in one of Palm Beach County's 39 municipalities should contact their municipality directly for holiday collection schedule information. A list of municipal contacts can be found online.

There are only two observed holidays during which residents in unincorporated Palm Beach County will not receive garbage service:

Thanksgiving Day: Thursday, Nov. 23, 2023

Christmas Day: Monday, Dec. 25, 2023

There will be normally scheduled collection services for unincorporated residents on the following days:

Christmas Eve: Sunday, Dec. 24, 2023

New Year's Eve: Sunday, Dec. 31, 2023

New Year's Day: Monday, Jan. 1, 2024
