Favorite thing .... Faith Stories. Over the years I've read and collected many faith stories shared by ordinary people. Their stories have encouraged me and strengthened my faith. Corrie Ten Boom's book "The Hiding Place" amazed me, as did her book, "Tramp for the Lord", where she writes of her travels all over the world, sharing the reality of Jesus Christ.

Who is the WHO? This week, we are writing about a situation causing deep concern among conservative leaders across our country. We're not sure if many people even know about it.

Dr. James Dobson, is one of those leaders. We share some of his interview with Michelle Bachmann former Minnesota Congresswoman, a candidate for U.S. president, now Dean of Government at Regent University.

Dr. Dobson begins, "The Biden Administration is on the verge of turning our keys of self-governance over to the World Health Organization. And mark my word, if America gives up its sovereign rule as a nation, we could well lose our sweet land of liberty."

"The Biden administration is proposing amendments that would transfer sovereign authority of the United States to the United Nations to make decisions over our health care. The proposal includes the other 194 countries. That decision making power of the US and all nations would transfer to the World Health Organization (WHO), the health care arm of the United Nations (UN)."

"What does that mean? Think about the last 3 years under the COVID pandemic and the extraordinary, breathtaking level of power that the United States took over its people. .... Closing businesses and schools,

mandating that people had to get shots whether they thought they needed them or not. Mandating mask wearing, lockdowns, closing churches. Look at the level of emergency power. It is this power that the Biden administration wants to give to the WHO."

"That would give WHO the power to shut us (the United States) down, tell us we must take shots or wear masks or any number of other things they would have the power to do."

"Effectively this is transferring sovereignty over the United States to the UN, and for the first time in history, we would create a platform for global governance."

Ms. Bachmann says, "The head of the Communist Party of China, Xi Jinping said, that China would be leading the global government in reform and governance. Communist China will lead, and they're serious about that because they're the ones who control and direct the WHO."

"The World Health Assembly meets the last week of May in Geneva Switzerland. All 194 nations will be there. The Biden administration is trying to persuade all nations to agree to transfer their sovereign authority to the World Health Organization. If they do that, it will end our authority. And that authority could be over issues like climate change and abortion." (see more in this paragraph)

"These amendments aren't going to come back to our Congress for approval. Because, on December 23, 2022 Congress passed the National Defense Authorization Act, signed by President Biden that states, 'Whatever the World Health Assembly adopts, we already approve it.'"

"The only solution," Ms. Bachman said, "is for us to get out of the World Health Organization." Our

previous president Donald Trump understood how evil and how wicked the actions of the WHO were. He defunded the WHO and gave notice to the UN that the United States was pulling out of WHO. But he did not return to the White House, so we are still in the WHO. Legislation is now in Congress (House Resolution 79, proposed by Rep. Andy Biggs) that says the U.S. is leaving the WHO. There needs to be the same bill in the Senate but it must happen quickly." Time is very short.

Dr. Dobson said, "Our nation's freedom is in serious jeopardy. We must not grow weary in doing what is right. America needs its people of liberty to rise up and be heard. I hope our readers will contact both houses of Congress using this number: 202/224-3121, and let them know we must withdraw from the World Health Organization."
