## Arcola third seed in sub-sectional A

 ARCOLA- The Class 1A regional pairings are out in girls basketball and Arcola is the No. 3 seeded team in Sub-Sectional A and is the host of a six-team regional tourney. Arcola, 21-7, plays the winner of the Heritage vs. Central A & M on Monday at 7:30 p.m. The other semifinal starts at 6 p.m. on Monday and pits Tri-County, the No. 2 seeded team, against the winner of the Meridian vs. Okaw Valley game. Arcola has played all teams except for Meridian. Arcola beat Central A&M 46-37 on Nov. 28 and beat Heritage 61-14 on Jan. 5. The Lady Riders also beat Okaw Valley 55-35 on Jan. 9 and lost

to Tri-County 53-23 on Jan. 23. Okaw Valley played all but Central A&M. Meridian beat Okaw Valley 49-37 on Nov. 16 and Okaw Valley lost to Tri-County 54-23. On Jan. 26 the Lady Timberwolves downed Heritage 60-17. Meridian lost to Central A&M 59-36 and 54-37 and has not played Heritage, Arcola or Tri-County. The Lady Titans have not played Meridian, Central A&M or Heritage. The winner advances to the Casey-Westfield Sectional and will play the winner of the
