Tourism grant

Governor JB Pritzker and the Illinois Department of Commerce & Economic Opportunity (DCEO) joined legislators and leaders in the tourism industry to award \$22.5 million in grant funding for 89 projects across Illinois through the Tourism Attractions and Festivals Grant program. Included is a \$500,000 grant to the Illinois Amish Heritage Center between Arthur and Arcola toward construction of a visitor's center.

Designed to support local festivals and attractions and drive tourism across the state, Illinois increased the funding available from \$15 million to \$22.5 million in order to support additional attractions. The additional \$7.5 million was secured during the Illinois General Assembly legislative session in early January 2023 and the program is funded by the American Rescue Plan Act (ARPA).

Illinois Supreme Court to appoint new judge for Douglas County

The Illinois Supreme Court will appoint a new circuit judge for Douglas County since Circuit Judge Richard L. Broch retired at the end of March.

An appointed judge would serve the county until November 2024. Afterward, an election would determine who would serve for a six-year period.

Currently, Douglas County only has one judge. Associate Judge Gary Webber works in Douglas, Piatt, Dewitt and Moultrie counties.

Illinois Supreme Court Justice David K. Overstreet put together a screening committee that will interview candidates and inform him who is qualified for the appointed position. So far, two candidates have applied, Attorney Andrew Bequette and States Attorney Kate Watson. They will have interviews on April 13.

Both candidates have a long history of working in Douglas County. Bequette has been working as an attorney for 20 years and spent 16 years of those in Tuscola. He currently works at the law office of Tumelson, Bryan & Knox in Ur-

bana. He previously worked at Beckett Law Office, P.C., which closed on Jan. 1. Bequette still sees clients at the Tuscola office on an appointment basis.

"I've had the privilege to serve every municipality [in Douglas County] except for Villa Grove," said Bequette.

Kate Watson has worked in Douglas County for 27 years. She started working as an assistant states' attorney in 1996. She was first elected Douglas County's states' attorney in 2016 and has been elected twice.

"I think I've been a fair prosecutor who has worked for justice for the community," said Watson.

Bequette said he has applied to be a judge several times. "I think it would be an incredible privilege and honor," said Bequette. He said his broad background in the law would be his biggest qualifier for the position. He has experience in criminal, family, and election law and more.

Bequette has also done appellate law, which is the process of appealing verdicts up the chain of courts for review.

Watson said she is the lead

law enforcement official in Douglas County. As a states' attorney, she has the responsibility of prosecuting felony, misdemeanor and traffic crimes committed in Douglas County.

She also represents Douglas County in any civil matters that may come up. Watson previously represented the county regarding some legal issues regarding wind farms. She also sued the state, along with Sheriff Nathan Chaplin, over the SAFE-T Act. She also serves as a chief legal advisor to the County

Board, county officials and department heads.

Both Bequette and Watson plan to run in the election following the judge's appointment. Bequette said he would start his election campaign if he were appointed judge.

Watson said the chairman of the republican party would recommend a replacement for the States Attorney position if she were appointed as judge.

The Douglas County judge appointment is expected to be announced later in April.

Low turn-out in April's county election

Only 1,277 ballots were cast in Douglas County's consolidated election April 4. That's just 11.04 percent of the 11,565 registered voters. There were few battles on the ballot, which consisted mostly of school board and city council elections. Some of the districts cross county lines, so votes from other counties may change the outcome in those elections.
