County Board appoints Health Board member New appointments for Ag board and Hayes Branch Drainage District

The Douglas County Board appointed Dr. Richard Davidson to the Public Health Board during the April 19 Board meeting. Dr. Davidson will replace Dr. Erin Parsons on the Public Health Board.

The Board also made several other appointments in the short monthly meeting.

Board member Gary Luth was appointed to the Douglas County Agriculture Board, replacing Board member Bibby Appleby.

The Board appointed Matthew Wesch to the Hayes Branch Drainage District No. 66-L-96. The appointment term will last until Sept. 1.

The Board reappointed Dustin Ingram as the Arcola Fire Department Trustee for a three-year term, starting July 1.

The Board approved an agreement for Animal Control Administrator Charles M. Knox.

The agreement states that Knox will oversee the shelter and any work that needs to be done for the shelter. Knox will

be paid \$3,500 per year and compensated with three trips to the animal control facility per week. The term for the agreement starts May 1 and ends on Dec. 31, 2024.

Board member Bibby Appleby said that Knox is doing a fine job. She added that there were 13 dogs at animal control available for fostering or adoption.

The Board approved the amendment of a lease agreement for office spaces at the Douglas County Annex. The amendments changed the effective dates of the two-year lease from May 1, 2023, to April 30, 2025.

The Board approved renewed liquor licenses for Aikman Wildlife, LLC, Kaskaskia County Club, and Tri-City Country Club

The Board approved the concrete crushing award for section 22-00142-00-MS to Ezell Excavation at \$9.25 per ton for crushing and screening organic material for a total contract price of \$185,000.
