

Rose's Bill to change rules for prescription pickup is headed to Governor Pritzker

SPRINGFIELD- Illinois is another step closer to ending an outdated practice that made it difficult, if not impossible, for many people to pick up their prescriptions, said State Sen. Chapin Rose (R-Mahomet). The Illinois General Assembly has passed legislation filed by Rose that would end what he said is "a ridiculous rule" that

required pharmacists to be present when people pick up their prescription, even if it was already filled, packaged, and signed off on by the licensed staff.

"I think everyone at some point has gone to their drug store to pick up a prescription that they were told was ready, but they are turned away be-

cause the pharmacist is out and no one else in the store is allowed by law to make the sale," said Rose. "This is a major issue for people who work nights shifts, have children, or simply have to work late."

Because of the rules and a statewide shortage of pharmacists, many pharmacies have cut back their hours, leaving

many patients without access to their potentially life-saving medicines, Rose said. This issue is especially problematic in rural areas.

Rose's legislation, Senate Bill 1889, would allow cash register clerks and other store employees to go ahead and process the sale of prescriptions that have been filled,

packaged, and sealed by pharmacists, even if the licensed staff is gone for the day.

"This is about access to care for many people. Children shouldn't go without life-saving insulin or asthma medicine because their parent had to work late; people shouldn't go without their heart medicines; no one should be without their prescription because of arcane and arbitrary government red tape," said Senator Rose.

Rose's bill, Senate Bill 1889, has passed both the Illinois Senate and House, and now awaits action by the Governor.

legislation to fix the discrepancy, which has now been passed by both chambers of the Illinois General Assembly.

"Bad guys don't care what department a cop works for, and when an officer gets hurt, it shouldn't matter either," said Rose. "They should get the same benefits whether they work for EIU PD or the City of Charleston PD."

Under current law, university police officers don't get the same benefits if they get hurt in the line of duty as municipal officers. Municipal police who are disabled in the line of duty, are eligible for benefits based on 65% of their pay. Whereas university police are only eligible for 50% under the same situations.

Rose's legislation, Senate Bill 1115, changes the benefits for the university police to match the same 65% as municipal police.

"Our brave men and women in blue need to know that we support them, and this is one small way that we can do that," said Rose.

Rose's legislation has now passed both chambers of the Illinois General Assembly and awaits action by the Governor.
